# **Presenting Papers**

## **Complaints of Breach of Privilege or Contempt and Personal Explanations**

Mr. President rendered the following decision regarding the request to rise on a point of privilege notified by Mr. Paradis, Official Opposition House Leader, on 11 June 1996, regarding the advertisement that was published in several Québec newspapers on the new drug insurance plan proposed in Bill 33:

# RULING FROM THE CHAIR

The request by the Official Opposition House Leader cannot be proceeded with on the following grounds: Information campaigns undertaken by the Ministries and public bodies in order to make the population aware of governmental decisions do not constitute, prima facie, a contempt of Parliament.

Nevertheless, government publicity regarding a bill that is still being considered by the National Assembly should mention the role of the National Assembly and of its Members with respect to the procedure followed for the passage of such new measures. A reminder of this requirement shall be addressed to the Government.

## **Oral Questions and Answers**

The Assembly proceeded to Oral Question Period.

By leave of the Assembly to set aside Standing Order 59, Mr. Chagnon (Westmount–Saint-Louis) tabled the following:

An audio cassette containing an excerpt from a speech made by Mr. Chevrette, Minister of State for Natural Resources.

Mr. President informed the Assembly that he was allowing the tabling of this audio cassette, with reservations as to the possibility of guaranteeing proper storage and reproduction of its contents by means of current techniques, and that he would give a directive on the tabling in the Assembly of audiovisual documents at a later time.

# **Deferred Divisions**

#### **Government Bills**

Report Stage

The Assembly took into consideration the report from the Committee on Labour and the Economy on its clause-by-clause consideration of Bill 21, An Act to amend the Act respecting the Société de récupération, d'exploitation et de développement forestiers du Québec.

The report was concurred in.

The Assembly took into consideration the report from the Committee on Planning and Infrastructures on its clause-by-clause consideration of Bill 1, An Act respecting the Ministère de la Métropole, together with the amendment handed in by Mr. Ménard, Minister of State for Metropolitan Montréal.

The amendment was declared in order.

At 1.00 o'clock p.m., Mr. President, having left the Chair, the proceedings were suspended until 3.00 o'clock p.m.

The proceedings resumed at 3.06 o'clock p.m.

Report Stage

The Assembly continued the consideration of the report from the Committee on Planning and Infrastructures on its clause-by-clause consideration of Bill 1, An Act respecting the Ministère de la Métropole, together with the amendment handed in by Mr. Ménard, Minister of State for Metropolitan Montréal.

The debate being concluded, the amendment was carried.

The report, as amended, was concurred in on division.

Passage

Mrs. Dionne-Marsolais, Minister for Industry and Trade, moved the passage of Bill 129, An Act to amend the Act respecting lotteries, publicity contests and amusement machines in respect of international cruise ships.

After debate thereon, the motion was carried and, accordingly, Bill 129 was passed.

By leave of the Assembly to set aside Standing Order 53, Mrs. Caron, Deputy Government House Leader, convened the following:

The Assembly took into consideration the report from the Committee on Planning and

Infrastructures on its clause-by-clause consideration of Bill 17, An Act to repeal the Act respecting the neighbourhood of Mont Sainte-Anne park.

The report was concurred in.

The Assembly took into consideration the report from the Committee on Planning and Infrastructures on its clause-by-clause consideration of Bill 24, An Act to amend the Cities and Towns Act, the Municipal Code of Québec and other legislative provisions.

The report was concurred in on division.

The Assembly took into consideration the report from the Committee on Labour and the Economy on its clause-by-clause consideration of Bill 26, An Act respecting the Ministère du Travail.

The report was concurred in on division.

The Assembly took into consideration the report from the Committee on Culture on its clause-by-clause consideration of Bill 28, An Act respecting the Société de télédiffusion du Québec and amending the Act respecting educational programming and other legislative provisions.

The report was concurred in.

Passage

Mr. Simard, Minister of International Relations, moved the passage of Bill 51, An Act respecting the implementation of international trade agreements.

After debate thereon, the motion was carried on division and, accordingly, Bill 51 was passed.

The report was concurred in on division.

The Assembly took into consideration the report from the Committee on Social Affairs on its clause-by-clause consideration of Bill 10, An Act to amend the Act respecting the Québec Pension Plan.

The report was concurred in.

#### Passage

Mr. Bégin, Minister of Justice, moved the passage of Bill 7, An Act to amend the Code of Civil Procedure, the Act respecting the Régie du logement, the Jurors Act and other legislative provisions.

After debate thereon, the motion was carried and, accordingly, Bill 7 was passed.

Passage in Principle

Mr. Landry, Minister of Finance, moved, –That Bill 14, An Act to amend the Real Estate Brokerage Act, do now pass in principle.

After debate thereon, the motion was carried on division and Bill 14 was accordingly passed in principle.

On motion by Mrs. Caron, Deputy Government House Leader, Bill 14 was referred for clause-by-clause consideration to the Committee on the Budget and Administration.

At 5.45 o'clock p.m., Mr. Pinard, Vice-President, having left the Chair, the proceedings were suspended until 8.00 o'clock p.m.

The proceedings resumed at 8.02 o'clock p.m.

Passage

Mr. Bégin, Minister of Justice, moved the passage of Bill 133, An Act to amend the Charter of human rights and freedoms and other legislative provisions.

After debate thereon, the motion was carried and, accordingly, Bill 133 was passed.

At 8.32 o'clock p.m., on the motion by Mrs. Caron, Deputy Government House Leader, the Assembly adjourned until Thursday, 13 June 1996, at 10.00 o'clock a.m.
