Motions Without Notice

Mr. Copeman (Notre-Dame-de-Grâce) moved:

THAT the Québec National Assembly join the eighty-four federal Members of the Liberal Party of Canada, of the Bloc Québécois, of the NDP and of the Reform Party who are asking that the banks and the department stores reduce forthwith the interest rate on credit cards by 50 %.

The debate being concluded, the motion was carried.

- X the Committee on Agriculture, Fisheries and Food shall hold a deliberative meeting for the purpose of organizing its proceedings.

Information on the Proceedings of the Assembly

Mr. Pinard, Vice-President, informed the Assembly that on Wednesday, 27 November 1996, during Business Standing in the Name of Members in Opposition, a debate will be held on the motion by Mr. Chagnon (Westmount–Saint-Louis). This motion reads as follows:

THAT the National Assembly request that the Prime Minister of Québec convene, as soon as possible, the Committee on the Budget and Administration to hear the unions affected by the government proposal regarding the reduction of manpower costs in the Québec public service.

ORDERS OF THE DAY

Government Bills

Passage in Principle

Mrs. Beaudoin, Minister of Culture and Communications, moved, —That Bill 64, An Act to amend the Act respecting the professional status and conditions of engagement of performing, recording and film artists and other legislative provisions, do now pass in principle.

After debate thereon, the motion was carried and Bill 64 was accordingly passed in principle.

On motion by Mr. Bélanger, Government House Leader, Bill 64 was referred for clause-byclause consideration to the Committee on Culture.

Mrs. Harel, Minister of Income Security and Minister responsible for the Status of Women, moved, —That Bill 68, An Act to amend the Civil Code of Québec and the Code of Civil Procedure as regards the determination of child support payments, do now pass in principle.

After debate thereon, the motion was carried and Bill 68 was accordingly passed in principle.

On motion by Mr. Bélanger, Government House Leader, Bill 68 was referred for clause-by-clause consideration to the Committee on Social Affairs.

At 5.59 o'clock p.m., Mr. Brouillet, Vice-President, having left the Chair, the proceedings were suspended until 8.00 o'clock p.m.

The proceedings resumed at 8.04 o'clock p.m.

Passage in Principle

Mr. Léonard, Minister for Administration and the Public Service, Chairman of the Conseil du Trésor, informed the Assembly that His Excellency the Lieutenant-Governor recommended to its consideration Bill 73, An Act respecting the Commission administrative des régimes de retraite et d=assurances and amending various legislative provisions as regards pension plans, and then moved —That this Bill do now pass in principle.

After debate thereon, the motion was carried and Bill 73 was accordingly passed in principle.

On motion by Mrs. Caron, Deputy Government House Leader, Bill 73 was referred for clause-by-clause consideration to the Committee on the Budget and Administration.

Mr. Chevrette, Minister of Natural Resources, moved, —That Bill 70, An Act to amend the Hydro-Québec Act, do now pass in principle.

After debate thereon, the motion was carried and Bill 70 was accordingly passed in principle.

On motion by Mrs. Caron, Deputy Government House Leader, Bill 70 was referred for clause-by-clause consideration to the Committee of the Whole.

On motion by Mrs. Caron, Deputy Government House Leader, the Assembly then resolved itself into a Committee of the Whole for the clause-by-clause consideration of Bill 70.

Clause-by-Clause Consideration in Committee of the Whole

The Committee of the Whole entered upon the clause-by-clause consideration of Bill 70, An Act to amend the Hydro-Québec Act.

The said Bill was carried by the Committee.

Bill 70 was thereupon reported to the Assembly, which concurred in the report from the Committee of the Whole.

Passage

By leave of the Assembly to set aside Standing Order 230, Mr. Chevrette, Minister of Natural Resources, moved the passage of Bill 70, An Act to amend the Hydro-Québec Act.

After debate thereon, the motion was carried and, accordingly, Bill 70 was passed.

Passage in Principle

Mr. Cliche, Minister of the Environment and Wildlife, moved, —That Bill 56, An Act to amend the Act respecting threatened or vulnerable species, do now pass in principle.

And debate arising;

On motion by Mrs. Caron, Deputy Government House Leader, the debate was adjourned.

Passage

Mr. Cliche, Minister of the Environment and Wildlife, moved the passage of Bill 53, An Act respecting reserved designations and amending the Act respecting the marketing of agricultural, food and fish products.

And debate arising;

On motion by Mrs. Caron, Deputy Government House Leader, the debate was adjourned.

Mr. Julien, Minister of Agriculture, Fisheries and Food, moved the passage of Bill 52, An Act to amend the Agricultural Products, Marine Products and Food Act and the Environment Quality Act.

And debate arising;

On motion by Mrs. Caron, Deputy Government House Leader, the debate was adjourned.

Debates Upon Adjournment

The Assembly held three debates upon adjournment:

- the first on a question by Mr. Cusano (Viau) to Mr. Rochon, Minister of Health and Social Services, about the resignation of Mr. Gilles Lagacé from Transplant Ouébec;
