The Assembly proceeded to Oral Question Period.

At the request of Mr. President, Mr. Williams (Nelligan) withdrew certain words deemed unparliamentary.

Deferred Divisions

The Assembly took the division, which had been deferred at the sitting of 10 December 1996, on the motion moved by Mr. Trudel, Minister of Municipal Affairs, for the passage in principle of Bill 67, An Act to establish an administrative review procedure for real estate assessment and to amend other legislative provisions.

The motion was carried on the following vote:

Accordingly, Bill 67 was passed in principle.

On motion by Mr. Bélanger, Government House Leader, Bill 67 was referred for clause-by-clause consideration to the Committee on Planning and Infrastructures.

Motions Without Notice

Mr. Brassard, Minister of Transport, moved:

THAT this Assembly mark the work accomplished by the 30,000 volunteers of Operation Nez rouge, for the past thirteen years, throughout Québec and acknowledge that it is thanks to the work of Mr. Jean-Marie De Koninck and his teams that it will have been possible for us to evolve towards a social consensus against driving under the influence of alcohol.

By leave of the Assembly under Standing Order 84, a debate arose thereon.

The debate being concluded, the motion was carried.

Mr. Boisclair, Minister of Relations with the Citizens and Immigration, moved:

THAT the National Assembly of Québec pay homage to Mr. André Leclerc, the recipient of the Rights and Freedoms award given yesterday by the Commission des droits de la personne et de la jeunesse, who is Director General and founder of Kéroul, an organization that has promoted, for more than fifteen years, access to tourist attractions for disabled persons.

By leave of the Assembly under Standing Order 84, the motion was carried. Mr. Bélanger, Government House Leader, moved:

THAT the Committee on Institutions, within the framework of its special consultations on Bill 65, An Act to institute, under the Code of Civil Procedure, pre-hearing mediation in family law cases and to amend other provisions of the Code, also hear the following group:

- the Association masculine d=entraide pour la famille

The terms and conditions regarding the consultation shall be identical to those stipulated for the other groups.

By leave of the Assembly under Standing Order 84, the motion was carried.

Notices of Proceedings in Committees

Mr. Bélanger, Government House Leader, convened the following Committees:

- X the Committee on Planning and Infrastructures, to give clause-by-clause consideration to Bill 43, An Act respecting off-highway vehicles, and to Bill 67, An Act to establish an administrative review procedure for real estate assessment and to amend other legislative provisions;
- X the Committee on Institutions, to continue its clause-by-clause consideration of Bill 77, An Act to amend the Police Act and other legislative provisions;
- X the Committee on Labour and the Economy, to continue its clause-by-clause consideration of Bill 78, An Act to amend various legislative provisions relating to the construction industry.

Government Bills

Report Stage

The Assembly took into consideration the report from the Committee on Institutions on its clause-by-clause consideration of Bill 130, An Act respecting administrative justice, together with the amendments handed in by Mr. Bégin, Minister of Justice, and by Mr. Mulcair (Chomedey).

Mr. Brouillet, Vice-President, declared these amendments to be receivable, after having corrected the form, pursuant to Standing Order 193, of the amendment handed in by the Minister to the English version of section 17 of the Bill.

Mr. Mulcair (Chomedey) having requested the translation of the amendments handed in by the Minister of Justice pursuant to Standing Order 252, Mr. Brouillet, Vice-President, took the matter under advisement and, for this purpose, at 11.30 o=clock a.m. suspended the proceedings during pleasure.

The proceedings resumed at 12.29 o=clock p.m.

Mr. Brouillet, Vice-President, gave the following directive on the request made by Mr. Mulcair:

DIRECTIVE FROM THE CHAIR

Pursuant to section 9 of the *Act respecting the National Assembly*, the Assembly establishes its rules of procedure and it alone has the authority to see that they are observed. This procedure, as stipulated in Standing Orders 179 and 180, is particularly determined by the usages and precedents of the Assembly. According to the usage of the Assembly, the amendments moved at any of the stages of the legislative process are handed in, depending on the choice of the author, either in French or in English; then, immediately their adoption in committee or in the Assembly, they are translated in the other language in order that both the French and English versions of the bill as amended are available before the royal assent, which is the final stage of the legislative process.
