The following Standing Orders be suspended until the aforementioned Bills shall have been passed:

19 (second paragraph), 20 to 22, 53 (the words "and personal explanations", in the fourth paragraph, as well as the seventh paragraph), 54 (the first, second, third and fifth paragraphs), 71 to 73, 84 (second and third paragraphs), 86 (the words "or at the request of some other Member", in the first paragraph, as well as the second paragraph), 87 (second, third and eighth paragraphs), 88 to 94, 100 and 101, 105 to 108, 110 to 114, 157, 164 and 165, 175 and 176, 177 (the words "and its observations, conclusions, or recommendations to the Assembly, if there be any"), 194 and 195, 205 to 209, 212, 213, 215, 216, 220, 230, 236 and 237, 239 (second paragraph), 240 and 241, 243, 244 (second paragraph), 245 and 246, 247, 248 (the words "and the bill shall thereupon be set down for final passage on a future sitting day", in the second paragraph), 249 to 251, 252 (first paragraph), 253 (first and third paragraphs), 254, 256 (second and third paragraphs), 257 and 304 to 307;

Immediately the present motion is carried, the Assembly shall have leave to continue the consideration of Bills 128, An Act to amend the Act respecting the conditions of employment in the public sector and the municipal sector, 76, An Act to establish a tourism partnership fund, 61, An Act to amend the Act respecting the Ministère de la Justice and other legislative provisions concerning the management

and disposition of proceeds of crime, 83, An Act to amend the Cities and Towns Act, the Municipal Code of Québec and other legislative provisions, 67, An Act to establish an administrative review procedure for real estate assessment and to amend other legislative provisions, 59, An Act to amend the Act respecting the conservation and development of wildlife, 30, An Act to amend the Act respecting the Société d'habitation du Ouébec:

Any Member shall be permitted to hand in to the office of the Secretary General, no later than thirty minutes after the passage of Bill 67, An Act to establish an administrative review procedure for real estate assessment and to amend other legislative provisions, a copy of such amendments as he wishes to propose thereto;

The debate on the consideration of a report from a Standing Committee and on the amendments already handed in or handed in in compliance with the present motion, shall last not more than fourteen minutes, immediately the present motion is carried, which period shall be allotted as follows: five minutes to the parliamentary group forming the Government, five minutes to the parliamentary group forming the Official Opposition, two minutes to the independent Members, and two minutes shall be allotted for a reply by the Minister presenting the Bill;

At the conclusion of the debate on the consideration of a Committee report, the questions for adoption of the amendments already handed in or handed in in compliance with the present motion shall be put successively, in the order indicated by the President; the amendments agreed to shall be included in the report and the Committee report, amended or not, shall then be voted on, and a recorded division may not be demanded;

The debate on the final passage of a Bill shall last not more than fourteen minutes, which period shall be allotted as follows: five minutes to the parliamentary group forming the Government, five minutes to the parliamentary group forming the Official Opposition, two minutes to the independent Members and two minutes to the Minister presenting the Bill for his reply; voting on the passage of the Bill shall be by a show of hands unless five Members demand a recorded division;

During the debate on the passage of a Bill, a Minister or a Deputy Government House Leader shall be permitted to move that the Assembly resolve itself into a Committee of the Whole to consider amendments that he indicates; the question on such motion, which requires no notice and may be neither amended nor debated, shall be put forthwith, and a recorded division may not be demanded thereon; the debate in Committee of the Whole shall be limited to consideration of the proposed

amendments; the debate in Committee of the Whole shall last not more than fifteen minutes, which period shall be allotted as follows: five minutes to the parliamentary group forming the Government, five minutes to the parliamentary group forming the Official Opposition, three minutes to the independent Members and two minutes to the Minister presenting the Bill for his reply, at the end of which period the question shall be put forthwith on the amendments, without debate and without recorded division, as well as on the amendments the Minister presenting the Bill may not have been able to move during clause-by-clause consideration; after which the Chairman of the Committee shall report to the Assembly, without consultation of the Committee nor the Assembly; the question on such report shall be put without recorded division;

A Minister or a Deputy Government House Leader shall be permitted to move that the Assembly resolve itself into a Committee of the Whole; the question on such motion, which requires no notice and may be neither amended nor debated, shall be put forthwith, and a recorded division may not be demanded thereon;

A Minister or a Deputy Government House Leader shall be permitted to move the adjournment of the debate at any time of the sitting; the question on such motion, which requires no notice and may be neither amended nor debated, shall be put forthwith, and a recorded division may not be demanded thereon;

A Minister or a Deputy Government House Leader shall be permitted to move the adjournment of the sitting at any time; the question on such motion, which requires no notice and may be neither amended nor debated, shall be put forthwith, and a recorded division may not be demanded thereon;

A Minister or a Deputy Government House Leader shall be permitted to move the withdrawal of a motion at any time of the sitting; the question on such motion, which requires no notice and may be neither amended nor debated, shall be put forthwith, and a recorded division may not be demanded thereon;

In addition to the provisions of this motion, all voting shall be by a show of hands unless a Minister or a Deputy Government House Leader demands a recorded division;

The Assembly be granted leave to meet each day at 10.00 o'clock a.m. and to continue sitting until it shall decide to adjourn;

Subject to the foregoing, the provisions of the Standing Orders of the Assembly relating to the months of June and December shall apply; and

The rules hereinbefore specified shall remain in force until Bills 128, An Act to amend the Act respecting the conditions of employment in the public sector and the municipal sector, 76, An Act to establish a tourism partnership fund, 61, An Act to amend the Act respecting the Ministère de la Justice and other legislative provisions concerning the management and disposition of proceeds of crime, 83, An Act to amend the Cities and Towns Act, the Municipal Code of Québec and other legislative provisions, 67, An Act to establish an administrative review procedure for real estate assessment and to amend other legislative provisions, 59, An Act to amend the Act respecting the conservation and development of wildlife, 30, An Act to amend the Act respecting the Société d'habitation du Québec, shall have been passed.

At 6.00 o'clock p.m., Mr. President having left the Chair, the proceedings were suspended until 8.00 o'clock p.m.

Mr. Lefebvre, Deputy Opposition House Leader, raised the question of the receivability of the motion to suspend certain rules of procedure moved by Mr. Bélanger, Government House Leader. He maintained that the time allotted for speeches could not be so reduced, that in the present situation the Chair should rule on the question of urgency and that, finally, the motion was in part unconstitutional.

Mr. President heard some comments on this question.

The proceedings resumed at 8.03 o'clock p.m.

During his speech, by leave of the Assembly to set aside Standing Order 59, Mr. Paradis, Official Opposition House Leader, tabled the following:

A copy of a letter, dated 13 December 1996, sent to Mr. Jean-Guy Alain, of the Association des hôteliers du Québec, from Mr. André Joli-Coeur, barrister with the Joli-Coeur, Lacasse, Lemieux, Simard, St-Pierre firm, concerning Bill 76, An Act to establish a tourism partnership fund.

(Sessional Paper No. 672-961220)

Mr. President took the matter under advisement and, for this purpose, suspended the proceedings.

Upon resumption of the proceedings, Mr. President rendered the following decision on the receivability of the motion to suspend certain rules of procedure moved by Mr. Bélanger, Government House Leader:

RULING FROM THE CHAIR

The motion is receivable on the following grounds: the time limits on speeches provided for in Standing Order 209 may be modified by means of a motion to suspend certain rules of procedure. The question as to whether or not there is urgency to move such a motion is left to the judgement of the Assembly and not of the Chair. Furthermore, the Chair may interpret, in the Constitution and statutes, only the provisions that contain a rule of parliamentary procedure.

After meeting with the leaders of the parliamentary groups, Mr. President announced the allocation of speaking time for the proceedings with respect to the limited debate on this motion by Mr. Bélanger, Government House Leader: Fifteen minutes shall be set aside for the independent Members; the two parliamentary groups shall share equally the rest of the time allotted for this debate; any time not used by a parliamentary group or by the independent Members may be redistributed, and individual addresses shall not otherwise be limited.

And debate arising on the motion moved by Mr. Bélanger, Government House Leader;

The debate being concluded, the motion was carried on division.

Passage

Mr. Cliche, Minister of the Environment and Wildlife, moved the passage of Bill 59, An Act to amend the Act respecting the conservation and development of wildlife.

And debate arising;

During the debate, Mr. Cliche, Minister of the Environment and Wildlife, moved that Bill 59, An Act to amend the Act respecting the conservation and development of wildlife, be referred to a Committee of the Whole for the consideration of an amendment that he specified.

This motion having been carried, Bill 59 was accordingly referred to a Committee of the Whole.

The amendment by Mr. Cliche, Minister of the Environment and Wildlife, to section 20 of Bill 59 was considered and then carried in Committee of the Whole.

Bill 59, as amended, was reported to the Assembly, which concurred in the Committee's report.

And debate continuing on the motion for the passage of Bill 59;

The debate being concluded, the motion was carried and Bill 59 was accordingly passed.

Report Stage

The Assembly resumed the debate on the consideration of the report from the Committee on the Budget and Administration on its clause-by-clause consideration of Bill 128, An Act to

amend the Act respecting the conditions of employment in the public sector and the municipal sector.

The report was concurred in on division.

Passage

Mr. Léonard, Minister for Administration and the Public Service, Chairman of the Conseil du Trésor, moved the passage of Bill 128, An Act to amend the Act respecting the conditions of employment in the public sector and the municipal sector.

The motion was carried on division and, accordingly, Bill 128 was passed.

Report Stage

Resuming the debate on the consideration of the report from the Committee on Labour and the Economy on its clause-by-clause consideration of Bill 76, An Act to establish a tourism partnership fund;

The report was concurred in on division.

Passage

Mrs. Dionne-Marsolais, Minister for Industry and Trade, moved the passage of Bill 76, An Act to establish a tourism partnership fund.

The motion was carried on division and, accordingly, Bill 76 was passed.

Report Stage

The Assembly took into consideration the report from the Committee on Institutions on its

clause-by-clause consideration of Bill 61, An Act to amend the Act respecting the Ministère de la Justice and other legislative provisions concerning the management and disposition of proceeds of crime.

The report was concurred in.

Passage

Mr. Bégin, Minister of Justice, moved the passage of Bill 61, An Act to amend the Act respecting the Ministère de la Justice and other legislative provisions concerning the management and disposition of proceeds of crime.

The motion was carried and, accordingly, Bill 61 was passed.

Mr. Trudel, Minister of Municipal Affairs, moved the passage of Bill 30, An Act to amend the Act respecting the Société d'habitation du Québec.

The motion was carried and, accordingly, Bill 30 was passed.

Report Stage

The Assembly took into consideration the report from the Committee on Planning and Infrastructures on its clause-by-clause consideration of Bill 67, An Act to establish an administrative review procedure for real estate assessment and to amend other legislative provisions.

After debate thereon, the report was concurred in on division.

Mr. Trudel, Minister of Municipal Affairs, moved the passage of Bill 67, An Act to establish an administrative review procedure for real estate assessment and to amend other legislative provisions.

The motion was carried on division and, accordingly, Bill 67 was passed.

Report Stage

The Assembly took into consideration the report from the Committee on Planning and Infrastructures on its clause-by-clause consideration of Bill 83, An Act to amend the Cities and Towns Act, the Municipal Code of Québec and other legislative provisions.

The report was concurred in.

Passage

Mr. Trudel, Minister of Municipal Affairs, moved the passage of Bill 83, An Act to amend the Cities and Towns Act, the Municipal Code of Québec and other legislative provisions.

The motion was carried and, accordingly, Bill 83 was passed.

At 11.11 o'clock p.m., on the motion by Mr. Bélanger, Government House Leader, the Assembly adjourned until Tuesday, 11 March 1997, at 2.00 o'clock p.m.
