

Motions Without Notice

Mr. Chevrette, Minister of State for Natural Resources, moved:

THAT this Assembly mark the 40th anniversary of Gaz Métropolitain, which constitutes one of the mainsprings of economic and energy development in Québec.

By leave of the assembly under standing order 84, the motion was carried.

Mr. Bordeleau (Acadie) moved:

THAT, on the occasion of the 82nd anniversary of the sad events surrounding the Armenian genocide that took place on 24 April 1915, the Québec National Assembly express its sympathy to the Armenian people, and more specifically to

the Armenian community of Québec, and remind all fellow Quebeckers of the terrible consequences of intolerance and racism.

By leave of the Assembly under Standing Order 84, a debate arose thereon.

The debate being concluded, the motion was carried. Mrs. Carrier-Perreault, Minister for Mines, Lands and Forests, moved:

THAT this Assembly mark Mining Week, which allows Quebeckers to better understand the economic importance of this industry which generates 18,000 direct jobs and which, in 1996, represented \$3.3 billion in value of production.

By leave of the Assembly under Standing Order 84, a debate arose thereon.
