The presentation by each group granted a thirty-minute hearing shall not last more than ten minutes and its exchange with the members of the Committee shall not last more than twenty minutes, which time shall be shared equally among the members of the parliamentary group forming the Government and the Members sitting in Opposition;

The Minister of Education and Minister responsible for Family Policy shall be a member of the said Committee during its proceedings with respect to this order of reference.

Government Bills

Passage in Principle

Mr. Boisclair, Minister of Relations with the Citizens and Immigration, moved, –That Bill 121, An Act to amend the Act respecting the Conseil permanent de la jeunesse and other legislative provisions, do now pass in principle.

And debate arising;

By leave of the Assembly to set aside Standing Order 53, Mr. Boisclair, Minister of Relations with the Citizens and Immigration, tabled the following:

A copy of a letter, dated 13 May 1997, he had received from Mr. Michel Philibert, Chairman of the Conseil permanent de la jeunesse, regarding Bill 121, An Act to amend the Act respecting the Conseil permanent de la jeunesse and other legislative provisions. (Sessional Paper No. 918-970530)

The debate being concluded, the motion was carried and Bill 121 was accordingly passed in principle.

On motion by Mr. Boisclair, Bill 121 was referred for clause-by-clause consideration to the Committee of the Whole.

On motion by Mr. Boisclair, the Assembly then resolved itself into a Committee of the Whole for the clause-by-clause consideration of Bill 121.

Clause-by-Clause Consideration in Committee of the Whole

The Committee of the Whole entered upon the clause-by-clause consideration of Bill 121, An Act to amend the Act respecting the Conseil permanent de la jeunesse and other legislative provisions.

Bill 121 was agreed to by the Committee of the Whole, with an amendment to section 14 of the English version and an amendment to section 18.

Bill 121, as amended, was thereupon reported to the Assembly, which concurred in the report from the Committee of the Whole.

Report Stage

The Assembly took into consideration the report from the Committee on Culture on its clause-by-clause consideration of Bill 40, An Act to amend the Charter of the French language.

And debate arising;

At 1.03 o'clock p.m., Mr. Brouillet, Vice-President, having left the Chair, the proceedings were suspended until 3.00 o'clock p.m.

The proceedings resumed at 3.01 o'clock p.m.

Report Stage

And debate continuing on the consideration of the report from the Committee on Culture on its clause-by-clause consideration of Bill 40, An Act to amend the Charter of the French language;

The debate being concluded, the question was put on this motion; a recorded division was thereupon demanded.

At the request of Mr. Bélanger, Government House Leader, the division was deferred until Routine Proceedings on the next sitting day.
