Motions Without Notice

By leave of the Assembly to set aside Standing Order 188, Mr. Jolivet, Government House Leader, moved:

THAT the Committee on Institutions hold special consultations on Bill 185, An Act respecting the election of the first commissioners of the new school boards and amending various legislative provisions, on Monday, 15 December 1997, and, for this purpose, hear the following groups:

- from 3.00 o=clock p.m. to 4.00 o=clock p.m., the Fédération des commissions scolaires:
- from 4.00 o=clock p.m. to 5.00 o=clock p.m., the Association des commissions scolaires;
- from 5.00 o=clock p.m. to 6.00 o=clock p.m., the Association des directeurs généraux des commissions scolaires catholiques;

The presentation by each group shall not last more than twenty minutes and its exchange with the members of the Committee shall not last more than forty minutes, which time shall be shared equally among the members of the parliamentary group forming the Government and the Members sitting in Opposition;

The Minister for Electoral and Parliamentary Reform shall be a member of the said Committee during its proceedings with respect to this order of reference.

Government Bills

Passage in Principle

And debate continuing on the motion by Mr. Rochon, Minister of Health and Social Services, —That Bill 176, An Act to amend the Act respecting the Ministère de la Santé et des Services sociaux and the Act respecting the Régie de l=assurance-maladie du Québec, do now pass in principle;

At the end of his address, Mr. Mulcair (Chomedey) moved the following motion to divide the said Bill:

THAT, pursuant to Standing Order 241, Bill 176 be divided into two Bills, the first of which shall be entitled "An Act to amend the Act respecting the Ministère de la Santé et des Services sociaux" and shall comprise sections 1 and 3, and the second of which shall be entitled "An Act respecting the Régie de l=assurance-maladie du Québec" and shall comprise sections 2 and 3.

Mr. Pinard, Vice-President, heard arguments from both sides regarding the receivability of this motion before taking this matter under advisement.

After a suspension of the proceedings, Mr. Pinard, Vice-President, rendered the following decision regarding the receivability of this motion:

RULING FROM THE CHAIR

The motion to divide is in order since each part of the divided bill can be considered separately and constitutes more than one modality. Furthermore, the bills ensuing from a division would constitute coherent bills in and of themselves. When the Chair must rule on the receivability of a motion to divide, it is not required to determine the legislator=s intent; it need only read the text without interpreting it.

At 5.45 o'clock p.m., by leave of the Assembly, Mr. Pinard, Vice-President, suspended the proceedings until 8.00 o'clock p.m.

The proceedings resumed at 8.07 o'clock p.m.

Passage in Principle

Following a meeting with the House Leaders, Mr. Pinard, Vice-President, announced the allocation of speaking time for the limited debate on this motion to divide: ten minutes shall be set aside for the independent Members; the two parliamentary groups shall equally share the rest of the time allotted for this debate; any time not used by a parliamentary group or by the independent Members may be redistributed, and individual addresses shall not otherwise be limited.

The Assembly entered upon the debate on the motion to divide moved by Mr. Mulcair.

After debate thereon, the question was put on this motion; a recorded division was thereupon demanded.

The motion was negatived on the following vote:

And debate continuing on the motion by Mr. Rochon, Minister of Health and Social Services, for the passage in principle of Bill 176, An Act to amend the Act respecting the Ministère de la Santé et des Services sociaux and the Act respecting the Régie de l=assurance-maladie du Québec;

At the end of his speech, Mr. Gautrin (Verdun) moved the adjournment of the debate,

pursuant to Standing Order 100.

After debate thereon, the question was put on this motion; a recorded division was thereupon demanded.
