Mr. President gave the following directive:

DIRECTIVE FROM THE CHAIR

Under section 35 of the Standing Orders, the *sub judice* rule stipulates that no Member speaking shall refer to any matter that is under adjudication before a court of law or a quasi-judicial body, or that is the subject of an inquiry, where such reference may be prejudicial to the interests of any person or party. This rule applies to the Assembly for the duration of judicial or quasi-judicial proceedings, or of an inquiry. Given that the Inquiry Commission into the appointment process for judges to the Court of Québec, municipal courts and the Tribunal administratif du Québec is such a body by definition, the rule applies.

Considering that the impact of words pronounced in the National Assembly is not as great as in criminal matters, the *sub judice* rule is not applied as strictly. Hence, a Member may, in a general manner, refer to a matter that is the subject of an inquiry; however, when approaching the heart of the matter, a Member may not make remarks that could be prejudicial to any person or party. Each Member has the responsibility to evaluate the margin at his disposal within the exercise of the privilege of freedom of speech at the Assembly.

Finally, Standing Order 82 stipulates that a minister may decline to answer if in providing the answer sought he would contravene the *sub judice* rule. The role of the Chair is not to appreciate the refusal to answer, this decision belonging solely to the Minister.

Government Bills

Passage in Principle

Mrs. Courchesne, Minister responsible for Government Administration and Chair of the Conseil du trésor, moved, –That Bill 112, An Act authorizing the making of collective agreements with a term of more than three years in the public and parapublic sectors, do now pass in principle.

After debate thereon, the motion was carried and Bill 112 was accordingly passed in principle.

Mr. Fournier, Government House Leader, moved that Bill 112 be referred for clause-by-clause consideration to the Committee on Public Finance.

The motion was carried.

Mr. Lessard, Minister of Municipal Affairs, Regions and Land Occupancy, moved, –That Bill 109, Municipal Ethics and Good Conduct Act, do now pass in principle.

After debate thereon, the motion was carried and Bill 109 was accordingly passed in principle.

Mr. Fournier, Government House Leader, moved that Bill 109 be referred for clause-by-clause consideration to the Committee on Planning and the Public Domain.

The motion was carried.
