Government Bills

Passage

Mrs. Thériault, Minister of Labour, moved the passage of Bill 111, An Act to amend the Act respecting labour standards in order to facilitate reciprocal enforcement of decisions ordering the payment of a sum of money.

After debate thereon, the motion was carried and, accordingly, Bill 111 was passed.

Passage in Principle

The Assembly resumed the debate, which had been adjourned on 28 September 2010, on the motion by Mr. Simard, Minister for Natural Resources and Wildlife, for the passage in principle of Bill 79, An Act to amend the Mining Act.

At 1.00 o'clock p.m., Mr. Gendron, Third Vice-President, suspended the proceedings until 3.00 o'clock p.m.

Accordingly, pursuant to Standing Order 97, the debate on the motion by Mr. Simard, Minister for Natural Resources and Wildlife, was adjourned in the name of Mr. Turcotte (Saint-Jean).

The proceedings resumed at 3.00 o'clock p.m.

Business Standing in the Name of Members in Opposition

Mr. Gaudreault (Jonquière) moved:

THAT the National Assembly demand that Hydro-Québec release as expeditiously as possible the information relating to all contracts granted from 2004 to 2010, particularly the names of the companies that submitted tenders, the method of awarding contracts, the amount of each bid, as well as the actual amount of disbursements, including cost overrun, for each contract granted, and that this motion become an order of the Assembly.

Mrs. Houda-Pepin, First Vice-President, informed the Assembly of the allocation of speaking time for the proceedings with respect to this motion: 10 minutes shall be allotted to the mover of the motion for his reply, 5 minutes shall be allotted to the Member for Mercier; 1 minute and 37 seconds shall be allotted to each of the other independent Members; 7 minutes and 42 seconds shall be allotted to the Second Opposition Group; the remaining time shall be shared equally among the parliamentary group forming the Government and the Members of the parliamentary group forming the Official Opposition, that is, 47 minutes for each of the two parliamentary groups; within this framework, any time not used by the independent Members of by the Members of the Second Opposition Group shall be redistributed equally between the parliamentary group forming the Government and the parliamentary group forming the Official Opposition; and any time not used by the parliamentary group forming the Government shall go to the parliamentary group forming the Official Opposition; and any time not used by the Official Opposition and vice versa. Lastly, individual addresses shall not be limited. The debate arose thereon.

By leave of the Assembly to set aside Standing Orders 53 and 59, Mr. Gaudreault (Jonquière) tabled the following:

The debate continued on the main motion by Mr. Gaudreault (Jonquière) and on the amendment by Mr. Gautrin (Verdun).

The debate being concluded, the question was put on the amendment motion; a recorded division was thereupon demanded.
