The Assembly was called to order at 1.45 o'clock p.m.

ROUTINE PROCEEDINGS

Statements by Members

Moment of reflection

Mr. President read an excerpt of a letter, dated 6 December 2010, addressed to Mr. Michel Bonsaint, Secretary General of the National Assembly, by Mr. Marcel Blanchet, Chief Electoral Officer of Québec, in relation to the by-election held on 29 November 2010 in the Electoral Division of Kamouraska-Témiscouata.

Mr. President then tabled the following:

The aforementioned letter accompanied by a notice proclaiming Mr. André Simard the candidate returned in the Electoral Division of Kamouraska-Témiscouata.

Introduction of Bills

Mr. President communicated to the Assembly and then tabled the report from the Law Clerk on the following Private Bill:

232 An Act respecting Municipalité régionale de comté des Appalaches

The report states that the notice was drafted and published in accordance with the Rules for the Conduct of Proceedings Respecting Private Bills.

The Assembly proceeded to Oral Question Period.

Motions Without Notice

By leave of the Assembly to set aside Standing Order 185, Mrs. Poirier (Hochelaga-Maisonneuve), together with Mrs. St-Pierre, Minister of Culture, Communications and the Status of Women, Mrs. Roy (Lotbinière), Mr. Picard (Chutes-de-la-Chaudière) and Mr. Khadir (Mercier), moved:

THAT the National Assembly of Québec remember the tragedy that took place at École Polytechnique de Montréal 21 years ago, on 6 December 1989;

THAT it ask each of its Members to commit to promoting equality, respect and non violence toward women within Québec society.

By leave of the Assembly, a debate arose thereon.

The debate being concluded, the motion was carried.

At the invitation of Mr. Chagnon, Second Vice-President, the Assembly observed a minute of silence.

Mr. Bonnardel (Shefford), together with Mr. Marceau (Rousseau) and Mr. Picard (Chutes-de-la-Chaudière), moved a motion concerning government expenses; this motion could not be debated for want of unanimous consent.

By leave of the Assembly to set aside Standing Order 185, Mrs. James, Minister of Families, together with Mrs. Poirier (Hochelaga-Maisonneuve) and Mr. Khadir (Mercier), moved:

THAT the National Assembly underline the historical character of the agreements-in-principle reached between the Government of Québec and both associations representing those responsible for home day care services: the Fédération de la santé et des services sociaux, affiliated with the Centrale des syndicats nationaux (FSSS-CSN), and the Fédération des intervenantes en petite enfance du Québec, affiliated with the Centrale des syndicats du Québec (FIPEQ-CSQ).

By leave of the Assembly, a debate arose thereon.

The debate being concluded, the motion was carried.

By leave of the Assembly to set aside Standing Orders 84.1 and 185, Mr. Lehouillier (Lévis), together with Mr. Marceau (Rousseau), Mr. Bonnardel (Shefford) and Mr. Picard (Chutes-de-la-Chaudière), moved:

THAT the National Assembly express to the Mouvement des caisses Desjardins, to its chair, Monique F. Leroux, to its 5,800,000 members as well as to its elected head officers and to all of its staff, its most sincere congratulations on having been awarded the coveted title of Bank of the Year 2010 in Canada by the British magazine The Banker;

THAT it underline the 110th anniversary of the founding of the Caisse populaire de Lévis, at the origin of the Mouvement Desjardins, the first cooperative financial group in Canada and a gem of modern Québec owing to its contribution to the sustainable prosperity of communities and to Québec's outreach.

ORDERS OF THE DAY

Government Bills

Report Stage

The Assembly took into consideration the report from the Committee on Transportation and the Environment on its clause-by-clause consideration of Bill 121, An Act to improve relations between the people living along off-highway vehicle club trails and the users of those trails and to improve user safety.

After debate thereon, the report was concurred in.

Passage in Principle

Mrs. Boulet, Minister of Employment and Social Solidarity, moved, –That Bill 129, An Act to amend various provisions respecting supplemental pension plans, particularly concerning payment options in the event of an employer's insolvency, do now pass in principle.

After debate thereon, the motion was carried on division and Bill 129 was accordingly passed in principle.

Mr. Dutil, Deputy Government House Leader, moved that Bill 129 be referred for clause-by-clause consideration to the Committee on Labour and the Economy.

The motion was carried.

Report Stage

The Assembly took into consideration the report from the Committee on Health and Social Services on its clause-by-clause consideration of Bill 125, An Act to facilitate organ and tissue donation.

After debate thereon, the report was concurred in.

Passage

Mr. Fournier, Minister responsible for the Reform of Democratic Institutions and Access to Information, moved the passage of Bill 113, An Act to put a stop to election contributions in the name of another.

After debate thereon, the question was put on this motion; a recorded division was thereupon demanded.

At the request of Mr. Dutil, Deputy Government House Leader, the division was deferred until Routine Proceedings on the next sitting day.

Report Stage

The Assembly took into consideration the report from the Committee on Institutions on its clause-by-clause consideration of Bill 114, An Act to increase the powers of oversight of the Chief Electoral Officer, together with the amendment handed in by Mr. Fournier, Minister responsible for the Reform of Democratic Institutions and Access to Information.

The amendment was declared in order.

By leave of the Assembly to set aside Standing Order 252, Mr. Fournier, Minister responsible for the Reform of Democratic Institutions and Access to Information, introduced an amendment.

The amendment was declared in order.

After debate thereon, the amendments were carried.

The report, as amended, was concurred in.

Mr. Dutil, Deputy Government House Leader, moved the adjournment of the Assembly until Wednesday, 8 December 2010, at 9.45 o'clock a.m.

The motion was carried.

Accordingly, at 5.44 o'clock p.m., Mr. Gendron, Third Vice-President, adjourned the Assembly until Wednesday, 8 December 2010, at 9.45 o'clock a.m.
