#### **Deferred Divisions**

The Assembly took the division, which had been deferred at the sitting of 10 February 2011, on the motion moved by Mrs. Weil, Minister of Immigration and Cultural Communities, in the name of Mr. Fournier, Minister of Justice, for the passage in principle of Bill 94, An Act to establish guidelines governing accommodation requests within the Administration and certain institutions.

The motion was carried on the following vote:

Yeas: 56 Nays: 49 Abstentions: 2

Accordingly, Bill 94 was passed in principle.

Mr. Fournier, Government House Leader, moved that Bill 94 be referred for clause-by-clause consideration to the Committee on Institutions.
