RULING FROM THE CHAIR

It does not devolve upon the Chair to demand that a Minister provide certain details when answering a question addressed to him. However, a Minister's answer must concern the subject on which he is questioned.

Deferred Divisions

The Assembly took the division, which had been deferred at the sitting of 16 March 2011, on the motion moved by Mrs. Roy (Lotbinière), together with Mr. Picard (Chutes-de-la-Chaudière), Mr. Caire (La Peltrie) and Mr. Khadir (Mercier).

THAT the National Assembly reiterate the primacy of the institution that is the Chief Electoral Officer for the delimitation of the electoral map and that it confirm that an electoral map delimited by a bill rather than by the CEOQ would be unlawful.

Motions Without Notice

By leave of the Assembly to set aside Standing Order 185, Mr. Drainville (Marie-Victorin), together with Mr. Lehouillier (Lévis), Mr. Deltell, Leader of the Second Opposition Group, Mr. Picard (Chutes-de-la-Chaudière) and Mr. Caire (La Peltrie), moved:

THAT the National Assembly ask the Federal Government to include Davie Yards in the invitation for bids on the upcoming 35 billion dollar contract, the most important contract in Canadian naval history.

By leave of the Assembly to set aside Standing Order 185, Mr. Arcand, Minister of Sustainable Development, Environment and Parks, together with Mrs. Ouellet (Vachon), Mr. Grondin (Beauce-Nord), Mr. Picard (Chutes-de-la-Chaudière) and Mr. Caire (La Peltrie), moved:

THAT the National Assembly underline World Water Day.

By leave of the Assembly, a debate arose thereon.

The debate being concluded, the motion was carried.

By leave of the Assembly to set aside Standing Orders 84.1 and 185, Mrs. Blais, Minister responsible for Seniors, together with Mrs. Lapointe (Crémazie), Mrs. Roy (Lotbinière), Mr. Picard (Chutes-de-la-Chaudière) and Mr. Caire (La Peltrie), moved:

THAT the National Assembly mark the 6th edition of Meals on Wheels Week, which is held from 20 to 26 March 2011; that this be a privileged moment to commend the work carried out by the volunteers whose role is paramount in the delivery of meals and the improvement of the quality of life of numerous elderly and disabled persons, while allowing them to remain and grow old in their home.

By leave of the Assembly, the motion was carried.

By leave of the Assembly to set aside Standing Order 84.1, Mr. Fournier, Government House Leader, moved:

THAT, under an agreement reached among the Government Members and the Members sitting in opposition and pursuant to the provisions of subparagraph 4.1 of the first paragraph of Standing Order 87 as well as Standing Orders 280 and 281, the Assembly shall consider and concur in Interim Supply for the 2011-2012 fiscal year as provided hereinafter:

THAT, immediately the Orders of the Day are entered upon, the Assembly shall resolve itself into a Committee of the Whole and consider Interim Supply in the following manner:

THAT, for a period of one hour, an exchange shall take place between the Minister of Natural Resources and Wildlife and the Members sitting in opposition;

THAT, immediately thereafter and for a period of one hour, an exchange shall take place between the Minister of Families and the Members sitting in opposition; THAT, afterwards and for a period of one hour, an exchange shall take place between the Minister of Education, Recreation and Sports and the Members sitting in opposition;

THAT after this exchange the Committee of the Whole shall suspend its proceedings and the proceedings of the Assembly shall be suspended until 7.30 o'clock p.m.;

THAT at 7.30 o'clock p.m. the Committee of the Whole shall resume its proceedings and, for a period of one hour, an exchange shall take place between the Minister of Finance and the Members sitting in opposition;

THAT, immediately thereafter and for a period of one hour, an exchange shall take place between the Minister responsible for Government Administration and Chair of the Conseil du trésor and the Members sitting in opposition;

THAT, immediately upon the conclusion of this exchange, the Chair of the Committee of the Whole shall put the question for concurrence in one quarter of the Estimates of Expenditure for the 2011-2012 fiscal year;

THAT the Chair of the Committee of the Whole shall thereupon report to the Assembly; and the question for concurrence in such report and that for passage of the consequent appropriation bill shall be put without debate, pursuant to the first paragraph of Standing Order 281;

THAT finally, and pursuant to the second paragraph of Standing Order 281, on a motion that the Government House Leader shall be permitted to move without notice and that may not be debated, the estimates of expenditure, save those for the National Assembly, shall be referred for consideration to the several Standing Committees;

THAT the opening statements for each of the exchanges with the Ministers shall not exceed five minutes for the parliamentary group forming the Government, five minutes for the parliamentary group forming the Official Opposition, and two minutes for the Second Opposition Group;

THAT during each of the exchanges with the aforementioned Ministers a period of four minutes shall be set aside for exchanges with the Members from the Second Opposition Group;

THAT during the exchange with the Minister of Natural Resources and Wildlife as well as that with the Minister of Education, Recreation and Sports a period of five minutes shall be set aside for the Member for Mercier:

THAT during the exchange with the Minister of Education, Recreation and Sports a period of five minutes shall be set aside for the Member for La Peltrie:

THAT during the exchange with the Minister of Finance a period of five minutes shall be set aside for the Member for Chutes-de-la-Chaudière;

THAT the President of the Assembly or the Chair of the Committee of the Whole shall be permitted to suspend the proceedings at any time;

THAT, notwithstanding Standing Order 20, the Committee of the Whole and the Assembly may continue their proceedings until the latter has voted on the appropriation bill and on the motion for the estimates of expenditure, save those for the National Assembly, to be referred for consideration to the several Standing Committees;

THAT the terms of this motion shall have precedence over any incompatible provisions of the Standing Orders;

THAT finally, this motion shall become an order of the Assembly.
