The Assembly was called to order at 9.46 o'clock a.m.

ROUTINE PROCEEDINGS

Oral Questions and Answers

The Assembly proceeded to Oral Question Period.

Motions Without Notice

Mr. Bonnardel (Shefford), together with Mr. Picard (Chutes-de-la-Chaudière) and Mr. Caire (La Peltrie), moved a motion concerning the Québec public service; this motion could not be debated for want of unanimous consent.

By leave of the Assembly to set aside Standing Order 185, Mrs. Houda-Pepin (La Pinière), together with Mr. Blanchet (Drummond), Mr. Deltell, Leader of the Second Opposition Group, Mr. Picard (Chutes-de-la-Chaudière), Mr. Caire (La Peltrie) and Mr. Khadir (Mercier), moved:

THAT the National Assembly of Québec underline this year the 125th anniversary of the Parliament Building, the work of Eugène-Étienne Taché;

THAT it celebrate this building which constitutes a true monument to the glory of the women and men who marked the history of Québec and French America;

THAT it recall that the Parliament of Québec held its first sitting in 1792, that the Members sat for the first time in our National Assembly Chamber on 8 April 1886, and that it is in this very place that, for the past 125 years, parliamentarians have represented their fellow citizens, voted laws and controlled the Government's actions;

THAT, finally, in 2011, the National Assembly invite all Quebecers to discover their Parliament, symbol of democracy and keeper of our history.

By leave of the Assembly, a debate arose thereon.

The debate being concluded, the motion was carried.

Mrs. Maltais (Taschereau) moved:

THAT the National Assembly acknowledge the position expressed by the 19 public health branches concerning the dangers of chrysotile asbestos for human health, and that it make certain that at the next meeting of the Committee on Agriculture, Fisheries, Energy and Natural Resources, the members may discuss a request for an order of initiative presented on 10 March 2011 regarding this matter.

By leave of the Assembly, the motion was carried.

By leave of the Assembly to set aside Standing Order 185, Mr. Caire (La Peltrie), together with Mrs. Gaudreault (Hull), Mr. Cloutier (Lac-Saint-Jean), Mr. Bonnardel (Shefford), Mr. Picard (Chutes-de-la-Chaudière) and Mr. Khadir (Mercier), moved:

THAT the National Assembly ask the Ministry of Foreign Affairs of Canada to make every effort to obtain the liberation of Lotfi Ghars, a Tunisian Canadian journalist established in Montréal since 1999, who has unjustly been held, according to the information received, for the past three weeks in Tripoli by the loyalist forces of Colonel Muammar Gaddafi.

By leave of the Assembly, the motion was carried.

Mr. Khadir (Mercier) moved a motion concerning chrysotile asbestos; this motion could not be debated for want of unanimous consent.

Pursuant to Standing Order 129, Mrs. Charlebois, Chief Government Whip, moved:

THAT the Member for Vimont be named a permanent member of the Committee on Citizen Relations;

THAT the Member for Jean-Lesage be named a permanent member of the Committee on Institutions;

THAT these modifications take effect immediately.

The motion was carried.

Notices of Proceedings in Committees

Mr. Gautrin, Deputy Government House Leader, convened the following Committees:

- the Committee on Public Finance, to conclude its public hearings within the framework of special consultations on Bill 133, An Act respecting the governance and management of the information resources of public bodies and government enterprises;

Government Bills

Passage in Principle

The Assembly resumed the debate, which had been adjourned on 6 April 2011, on the motion by Mr. Arcand, Minister of Sustainable Development, Environment and Parks, for the passage in principle of Bill 89, An Act to amend the Environment Quality Act in order to reinforce compliance.

The debate being concluded, the motion was carried and Bill 89 was accordingly passed in principle.

Mr. Fournier, Government House Leader, moved that Bill 89 be referred for clause-by-clause consideration to the Committee on Transportation and the Environment.

The motion was carried.

Mr. Bolduc, Minister of Health and Social Services, moved, –That Bill 127, An Act to improve the management of the health and social services network, do now pass in principle.

A debate arose thereon.

At 12.59 o'clock p.m., Mr. Gendron, Third Vice-President, suspended the proceedings until 3.00 o'clock p.m.

The proceedings resumed at 3.01 o'clock p.m.

Passage in Principle

The debate continued on the motion by Mr. Bolduc, Minister of Health and Social Services, for the passage in principle of Bill 127, An Act to improve the management of the health and social services network.

The debate was adjourned in the name of Mr. Charette (Deux-Montagnes).
