By leave of the Assembly to set aside Standing Order 116 (1), Mrs. Houda-Pepin, First Vice-President, moved:

THAT the Standing Orders of the National Assembly be amended by the provisions contained in the documents entitled "Proposed amendments to the Standing Orders of the National Assembly in light of the adoption of the Code of ethics and conduct of the Members of the National Assembly", "Proposed amendment to the Standing Orders of the National Assembly concerning the time limit for handing in a notice relating to Business Standing in the Name of Members in Opposition" and "Proposed amendments to the Standing Orders of the National Assembly consequential to the adoption of the Code of ethics and conduct of the Members of the National Assembly";

THAT the amendments contained in the documents "Proposed amendments to the Standing Orders of the National Assembly in light of the adoption of the Code of ethics and conduct of the Members of the National Assembly" and "Proposed amendment to the Standing Orders of the National Assembly concerning the time limit for handing in a notice relating to Business Standing in the Name of Members in Opposition" enter into force immediately;

THAT the amendments contained in the document "Proposed amendments to the Standing Orders of the National Assembly in light of the adoption of the Code of ethics and conduct of the Members of the National Assembly" enter into force on the day of the entry into force of sections 10 to 36 of the Code of ethics and conduct of the Members of the National Assembly;

THAT these amendments be included in the Votes and Proceedings of the National Assembly as part of this motion.

PROPOSED AMENDMENTS TO THE STANDING ORDERS OF THE NATIONAL ASSEMBLY IN LIGHT OF THE ADOPTION OF THE CODE OF ETHICS AND CONDUCT OF THE MEMBERS OF THE NATIONAL ASSEMBLY

THAT Standing Order 8.5 of the Standing Orders of the National Assembly be amended by inserting "the Ethics Commissioner or, if the Ethics Commissioner is unable to act, in the presence of" after "in the presence of";

Standing Order 8.5 as amended would read as follows:

**8.5.** Counting the votes – The Secretary General shall count the votes, in the presence of the Ethics Commissioner or, if the Ethics Commissioner is unable to act, in the presence of the Jurisconsult, in some place outside the Assembly Chamber. The election of the President having been concluded, the Secretary General shall destroy all ballot papers together with any record that may show the number of votes received by any candidate.

No person present when the ballots are counted shall divulge the number of votes received by any candidate.

THAT Standing Order 294 of the Standing Orders of the National Assembly be amended by inserting the following paragraph after the first paragraph:

"A public body is a body to which the National Assembly, the Government or a minister appoints the majority of the members, to which, by law, the personnel is appointed in accordance with the *Public Service Act* (R.S.Q., chapter F-3.1.1), or whose capital forms part of the domain of the State.";

Standing Order 294 as amended would read as follows:

**294.** Examination in committee — Every committee shall examine each year the policy directions, activities, and management of at least one public body that is subject to its power of surveillance.

A public body is a body to which the National Assembly, the Government or a minister appoints the majority of the members, to which, by law, the personnel is appointed in accordance with the Public Service Act (R.S.Q., chapter F 3.1.1), or whose capital forms part of the domain of the State.

Public bodies shall be selected for examination as provided in Standing Order 149. Failing agreement thereon, the Committee on the National Assembly shall designate the bodies that are to be heard.

PROPOSED AMENDMENT TO THE STANDING ORDERS OF THE NATIONAL ASSEMBLY CONCERNING THE TIME LIMIT FOR HANDING IN A NOTICE RELATING TO BUSINESS STANDING IN THE NAME OF MEMBERS IN OPPOSITION

THAT the first paragraph of Standing Order 97.1 of the Standing Orders of the National Assembly be amended by replacing "three hours before the Routine Proceedings are to be entered upon" by "12.00 o'clock noon";

The first paragraph of Standing Order 97.1 as amended would read as follows:

**97.1. Notice** — A Member wishing to move a motion under Business Standing in the Name of Members in Opposition shall, not later than 12.00 o'clock noon on the sitting day prior to that on which such business is to be taken, hand in a notice thereof for publication in the Order Paper and Notices.

PROPOSED AMENDMENTS TO THE STANDING ORDERS OF THE NATIONAL ASSEMBLY CONSEQUENTIAL TO THE ADOPTION OF THE CODE OF ETHICS AND CONDUCT OF THE MEMBERS OF THE NATIONAL ASSEMBLY

THAT Standing Order 316 of the Standing Orders of the National Assembly be amended by striking out paragraph (1) and by replacing "in paragraphs (1) and (2) of this Standing Order" in paragraph (3) by "in paragraph (2) of this Standing Order or in the Code of ethics and conduct of the Members of the National Assembly";

Standing Order 316 as amended would read as follows:

**316. Grounds** — A Member may, by means of such motion:

- (1) [repealed];
- (2) complain that some other Member has breached the privileges of the Assembly or one of its members;
- (3) impugn an act, not being a situation envisaged in paragraph (2) of this Standing Order or in the Code of ethics and conduct of the Members of the National Assembly, accomplished by a Member of Parliament in the course of his duties.

THAT Standing Order 317 of the Standing Orders of the National Assembly be amended by striking out "that he holds or has held incompatible offices, or that he has been in a conflict of interest,";

Standing Order 317 as amended would read as follows:

**317. Announcement of motion** — When it is complained that some Member has breached the privileges of the Assembly or one of its members, the Member so complaining shall first raise a question of privilege and then announce that he intends to move a motion impugning this conduct.

THAT Standing Order 323 of the Standing Orders of the National Assembly be amended by replacing ", or the holding of incompatible offices, or any conflict of interest" by "or a situation envisaged in the Code of ethics and conduct of the Members of the National Assembly";

Standing Order 323 as amended would read as follows:

323. Committee on the National Assembly not convened — When complaint is made of an act accomplished by a Member of Parliament in the course of his duties, not being a breach of the privileges of the Assembly or one of its members or a situation envisaged in the Code of ethics and conduct of the Members of the National Assembly, the Assembly may dispose of the motion to that effect without the Committee on the National Assembly's first having been convened.

Such motion may be neither amended nor divided.

#### Complaints of Breach of Privilege or Contempt and Personal Explanations

Mr. President rendered his decision regarding the request to rise on a point of privilege or contempt notified by the Member for Saint-Maurice last 27 September, whereby he alleged that Mr. André Forcier, chairman of the administrative board of La Financière agricole du Québec, was in contempt of Parliament when he failed to appear as a witness before the Committee on Agriculture, Fisheries, Energy and Natural Resources, after having been summoned to do so.

#### **RULING FROM THE CHAIR**

There is no doubt that the Committee acted in compliance with its constitutional power to summon a witness to appear before it. Mr. Forcier had the obligation to comply with the Committee's order and could not take the decision on his own initiative to fail to do so. The fact that he offered to appear before the Committee on some other date in no way changes the Chair's ruling. It is up to the Committee to determine its agenda and not to the witnesses.

The participation of heads and administrators of public agencies is essential to the proceedings of the Assembly and committees. They must, by their behaviour, refrain from undermining their proper conduct. They must at all times keep in mind that the Assembly has the power to demand accounts and they have the duty to give them.

Similarly to the judicial branch of the State, the legislative branch – the Parliament – has the right to respect for the efficient exercise its role, and an order to appear before the Assembly is not less serious than an order to appear before a court.

The fact that Mr. Forcier did not comply with the order to appear before the Committee in spite of the obligation to do so without a doubt constitutes, at first glance, a contravention of paragraph 1 of section 55 of the *Act respecting the National Assembly*. The role of the Chair, at this stage, is to determine whether the facts raised are sufficiently compelling to constitute, at first glance, contempt of Parliament. It is for the Assembly itself to subsequently determine whether there was indeed contempt of Parliament.

In the present case, while the Chair may come to the conclusion that there is, at first glance, contempt of Parliament, no action will be taken since the Member for Saint-Maurice did not mention, in his notice, if he intended to move a motion asking the Assembly to take a decision on the conduct of Mr. Forcier. This by no means takes away from the gravity of the ruling, and the Chair hopes that it will serve as a warning to any person who would choose to disobey an order to appear before a parliamentary committee.

#### **Oral Questions and Answers**

The Assembly proceeded to Oral Question Period.

At the request of Mr. President, Mr. Drainville (Marie-Victorin) withdrew certain words deemed unparliamentary.

THAT the National Assembly express its deepest condolences to the family and friends of Mr. Pierre Dansereau, internationally renowned, eminent Québec biologist;

THAT it recognize the outstanding work carried out by this researcher, professor, philosopher and pioneer of global ecology throughout his long career.

This motion reads as follows:

THAT the National Assembly affirm that the best interests of Québec as well as the rights and powers of the National Assembly must be protected within the framework of the Canada-Europe Comprehensive Economic and Trade Agreement negotiations;

THAT it ask the Government of Québec to instruct its representatives to ensure that all appropriate interventions be carried out, particularly with regard to the protection of cultural and linguistic diversity, protection of the environment, the development of natural resources and the National Assembly's power to adopt public policies in the general interest of the population of Québec;

THAT it may examine the text of the Agreement and comment thereon before it is signed, within the framework of a parliamentary committee.

Mrs. Houda-Pepin, First Vice-President, informed the Assembly of the allocation of speaking time for the proceedings with respect to this limited debate: 8 minutes 24 seconds shall be allotted to the Members of the Second Opposition Group; 10 minutes shall be granted to the independent Members; the rest of the time set aside for this debate shall be shared equally between the parliamentary group forming the Government and the parliamentary group forming the Official Opposition. Within this framework, any time not used by the independent Members or by the Members of the Second Opposition Group shall be redistributed equally between the parliamentary group forming the Government and the parliamentary group forming the Official Opposition; and any time not used by the parliamentary group forming the Government shall go to the parliamentary group forming the Official Opposition and vice versa. Lastly, individual addresses shall not be limited.

The debate arose thereon.

The debate expired and, pursuant to Standing Order 95, no question was put.
