Deferred Divisions

The Assembly took the division, which had been deferred at the sitting of 2 November 2011, on the motion moved by Mrs. Thériault, Minister of Labour, for the passage in principle of Bill 33, An Act to eliminate union placement and improve the operation of the construction industry.

The motion was carried on the following vote:

Accordingly, Bill 33 was passed in principle.

Mr. Fournier, Government House Leader, moved that Bill 33, An Act to eliminate union placement and improve the operation of the construction industry, be referred for clause-by-clause consideration to the Committee on Labour and the Economy.

The motion was carried.

Motions Without Notice

Mrs. Roy, Second Opposition Group House Leader, together with Mr. Bergeron (Verchères), Mrs. Lapointe (Crémazie) and Mr. Gauvreau (Groulx), moved a motion concerning the fight against cyber crime; this motion could not be debated for want of unanimous consent.

Mr. Dutil, Minister of Public Security moved:

THAT the National Assembly recall the existence of cyber crime alert websites, such as www.sq.gouv.qc.ca, and www.cyberaide.ca, designed so that law enforcement officers may be alerted when young people are victims of online predators.

By leave of the Assembly, a debate arose thereon.

The debate being concluded, the motion was carried.

Mr. Drainville (Marie-Victorin) moved a motion concerning the 30th anniversary of the Federal-Provincial Constitutional Agreement of 5 November 1981; this motion could not be debated for want of unanimous consent.

Mr. Curzi (Borduas), together with Mr. Marceau (Rousseau), Mrs. Lapointe (Crémazie), Mr. Gauvreau (Groulx) and Mrs. Beaudoin (Rosemont), moved a motion concerning financial transaction taxation; this motion could not be debated for want of unanimous consent.

By leave of the Assembly to set aside Standing Order 84.1, Mrs. Poirier (Hochelaga-Maisonneuve) moved:

THAT the National Assembly condemn the violent acts committed on the premises of the French weekly Charlie Hebdo and that it reaffirm its unwavering support for freedom of the press.

By leave of the Assembly, the motion was carried.

Notices of Proceedings in Committees

Mr. Gautrin, Deputy Government House Leader, convened the following Committees:

- the Committee on Health and Social Services, to continue its clause-byclause consideration of Bill 16, An Act to amend various legislative provisions concerning health and social services in order, in particular, to tighten up the certification process for residences for the elderly;
- the Committee on Public Finance, to continue its clause-by-clause consideration of Bill 7, An Act to amend various legislative provisions concerning the financial sector;
- the Committee on Labour and the Economy, to give clause-by-clause consideration to Bill 33, An Act to eliminate union placement and improve the operation of the construction industry;
- the Committee on Institutions, to continue its clause-by-clause consideration of Bill 120, An Act respecting political party leadership campaigns;
- the Committee on Agriculture, Fisheries, Energy and Natural Resources, to continue its clause-by-clause consideration of Bill 14, An Act respecting the development of mineral resources in keeping with the principles of sustainable development.

Mr. Gendron, Third Vice-President, gave the following notices:

the Committee on Public Administration shall hold a deliberative meeting to prepare the hearing as a follow-up to the Committee's 24th report on the management of contracts presenting risk situations at the Ministère des Transports; it shall then hold a public meeting to hear the Deputy Minister of Transport; and finally, it shall hold a deliberative meeting to discuss the observations, conclusions and recommendations, if any, following this hearing;

the Select Committee on Dying with Dignity shall hold a deliberative meeting to continue drafting its report.

Mr. Gendron, Third Vice-President, informed the Assembly that on Friday, 11 November 2011, Mrs. Malavoy (Taillon) would question Mrs. Beauchamp, Minister of Education, Recreation and Sports, during an interpellation on "the increase in tuition fees imposed by the Liberal government in 2012".
