(10) Mr. Gaudreault (Jonquière) – **2 November 2011**To the Minister of Natural Resources and Wildlife:

For the past several months, I have been working at developing a portrait of the situation with regard to the use of public domain hydraulic powers by the AbitibiBowater company in the Saguenay–Lac-Saint-Jean region. In March 2011, through a request made in pursuance of the *Act respecting Access to documents held by public bodies and the Protection of personal information*, I obtained from the Ministère des Ressources naturelles et de la Faune (MRNF) a series of leases and contracts. The Ministère indicated at that time that it did not have in its possession the documents concerning the Chicoutimi power plant on the Chicoutimi River and the Bésy and Jonquière power plants on the Aux Sables River.

Last 17 October, the Radio-Canada radio station in the Saguenay region broadcast news to the effect that hydraulic power was leased to AbitibiBowater for only four of the eight power plants that it operates in the region. Philippe Desjardins of the MNRF stated that in the early 1900's, the Québec Government, to promote economic development, sold, under full ownership, certain hydraulic powers and the lands required to operate them to some companies.

I would like to receive explanations and documents (contracts or other agreements) indicating to whom belong the hydraulic powers used to operate the Murdock-Wilson power plant on the Shipshaw River, the Jonquière and Bésy power plants on the Aux Sables River, as well as the Chicoutimi power plant on the Chicoutimi River, and how the operation of these hydraulic powers is governed.

(12) M. Khadir (Mercier) – **7 December 2011**To the Premier:

Within the framework of the negotiations of the Comprehensive Economic and Trade Agreement between Canada and the European Union, what provincial and municipal public contracts are currently under discussion and what are the specific offers made by Québec in this regard?

(13) M. Khadir (Mercier) – **7 December 2011**To the Premier:

Within the framework of the negotiations relating to the Comprehensive Economic and Trade Agreement between Canada and the European Union, what influential meetings were held to prepare the negotiating mandates?

(14) M. Khadir (Mercier) – **7 December 2011**To the Premier:

Given that Mr. Pierre Marc Johnson is legal counsel at Heenan & Blaikie, whose areas of specialization include international trade, the mining sector and infrastructure, why did the Government of Québec prefer to hire Mr. Johnson rather than a diplomat or a civil servant to represent Québec's interests during the negotiations between Canada and the European Union within the framework of the CETA? Does the contract signed by Mr. Johnson contain clauses that prohibit him from taking the information gathered during these negotiations and using it in the private sector?

(15) M. Khadir (Mercier) – **7 December 2011**To the Premier:

Among the principles contained in the *Sustainable Development Act* is the subsidiarity principle whereby powers and responsibilities must be delegated in order to bring them as close as possible to the citizens and communities involved. Yet the Comprehensive Economic and Trade Agreement between Canada and the European Union will transfer a major legislative and regulatory power to the courts to resolve trade disputes. In the absence of prior consultations with the Members of the National Assembly and with municipal elected officials, how does the Government of Québec intend to comply with its own *Sustainable Development Act*?

(16) M. Khadir (Mercier) – **7 December 2011**To the Premier:

The Act to Combat Poverty and Social Exclusion provides that all government actions must be accompanied by a study regarding the impact on the most destitute members of society and on the increasing gap between the richest and poorest members of society. On what studies does the government base itself to ensure that the Comprehensive Economic and Trade Agreement between Canada and the European Union does not violate the objectives of the fight against poverty, since the multiple free-trade agreements reached over the past 25 years have resulted in an unprecedented increase in economic inequality in Canada?
