A period of 15 minutes shall be allotted for the closing statements, which time shall be shared equally among the members of the parliamentary group forming the Government and the Members sitting in opposition;

The Minister of Transport shall be a member of the said Committee during its proceedings with respect to this order of reference.

Pursuant to Standing Order 186, Mr. Dutil, Deputy Government House Leader, moved:

THAT the motion carried on 20 March 2012, which ordered the Committee on Health and Social Services to hold special consultations within the framework of its consideration of Bill 53, An Act to dissolve the Société de gestion informatique SOGIQUE, be rescinded.

#### **Business Having Precedence**

Debate on the Budget Speech

The Assembly resumed the debate, which had been adjourned on 22 March 2012, on the motion by Mr. Bachand, Minister of Finance, —That this Assembly approves in general the budgetary policy of the Government, and on the motions stating a grievance moved by Mr. Marceau (Rousseau), Mr. Simard (Richelieu), Mr. Pelletier (Rimouski) and Mr. Drainville (Marie-Victorin), subject to the receivability of these motions.

At the end of his speech, Mr. Khadir (Mercier) moved the following motion stating a grievance:

THAT the National Assembly severely censure the Liberal Government and its 2012-2013 budget for having disregarded public opinion calling for the abolition of the health tax and the cancellation of the \$1625 increase in tuition fees, for having failed to significantly increase public scrutiny and participation in the natural resources sector, and for having failed to lay the foundation for job creation in Québec based on a greener solidarity economy.

The debate continued on the motion by Mr. Bachand, Minister of Finance, and on the motions stating a grievance moved by Mr. Marceau (Rousseau), Mr. Simard (Richelieu), Mr. Pelletier (Rimouski), Mr. Drainville (Marie-Victorin) and Mr. Khadir (Mercier), subject to the receivability of these motions.

At the end of her speech, Mrs. Maltais (Taschereau) moved the following motion stating a grievance:

THAT the National Assembly severely censure the Liberal Government for its stubbornness in maintaining the health tax, which directly penalizes all Quebecers, particularly the middle class.

The debate continued on the motion by Mr. Bachand, Minister of Finance, and on the motions stating a grievance moved by Mr. Marceau (Rousseau), Mr. Simard (Richelieu), Mr. Pelletier (Rimouski), Mr. Drainville (Marie-Victorin), Mr. Khadir (Mercier) and Mrs. Maltais (Taschereau), subject to the receivability of these motions.

At the end of her speech, Mrs. Marois, Leader of the Official Opposition, moved the following motion stating a grievance:

THAT the National Assembly severely censure the Liberal Government, which, in tabling its 2012-2013 budget, has failed to fulfil its economic and financial responsibilities by attacking middle-class families and students, while proving its inability to defend Québec's interests in Ottawa.

The debate continued on the motion by Mr. Bachand, Minister of Finance, and on the motions stating a grievance moved by Mr. Marceau (Rousseau), Mr. Simard (Richelieu), Mr. Pelletier (Rimouski), Mr. Drainville (Marie-Victorin), Mr. Khadir (Mercier), Mrs. Maltais (Taschereau) and Mrs. Marois, Leader of the Official Opposition, subject to the receivability of these motions.

At the end of his speech, Mr. McKay (L'Assomption) moved the following motion stating a grievance:

THAT the National Assembly severely censure the Liberal Government for the lack of necessary resources to ensure the ecological planning of the entire territory located north of the 49<sup>th</sup> parallel and for its failure to commit to the environmental protection of 50 % of this territory.

The debate continued on the motion by Mr. Bachand, Minister of Finance, and on the motions stating a grievance moved by Mr. Marceau (Rousseau), Mr. Simard (Richelieu), Mr. Pelletier (Rimouski), Mr. Drainville (Marie-Victorin), Mr. Khadir (Mercier), Mrs. Maltais (Taschereau), Mrs. Marois, Leader of the Official Opposition, and Mr. McKay (L'Assomption), subject to the receivability of these motions.

At the end of her speech, Mrs. Malavoy (Taillon) moved the following motion stating a grievance:

THAT the National Assembly censure the Government for maintaining its 75 % increase in tuition fees over a five-year period, as well as for its stubbornness in refusing to enter into a dialogue with the students and thus work toward settling the student strike.
