Oral Questions and Answers

The Assembly proceeded to Oral Question Period.

At the request of Mr. President, Mrs. St-Pierre, Minister of Culture, Communications and the Status of Women, withdrew certain words deemed unparliamentary.

Motions Without Notice

Mr. Charest, Premier, moved:

THAT, pursuant to sections 26 and 121 of the *Act respecting the National Assembly* (R.S.Q., c. A-23.1), M^e Jacques Jobin hereby be reappointed Associate Secretary General of the National Assembly for a term of seven years, that he be vested with the rank and privileges of an assistant deputy minister and that he hold this office until he has been replaced or reappointed.

Mr. Charest, Premier, then tabled the following:

THAT the National Assembly reaffirm the right of women to freedom of choice and to free and accessible abortion services and ask the federal Government and the Prime Minister of Canada to put an end to the ambiguity that persists in relation to this question.

By leave of the Assembly, the motion was carried.

By leave of the Assembly to set aside Standing Orders 84.1 and 185, Mrs. Thériault, Minister of Labour, together with Mr. Dufour (René-Lévesque), Mr. Ratthé (Blainville), Mr. Curzi (Borduas), Mrs. Lapointe (Crémazie) and Mr. Khadir (Mercier), moved:

THAT the National Assembly underline Memorial Day for Persons Killed or Injured on the Job that will be held next Saturday, 28 April.

By leave of the Assembly, the motion was carried.

At the invitation of Mrs. Houda-Pepin, First Vice-President, the Assembly observed a minute of silence.

Mr. Khadir (Mercier), together with Mr. Aussant (Nicolet-Yamaska), moved a motion concerning the increase in university tuition fees; this motion could not be debated for want of unanimous consent.

By leave of the Assembly to set aside Standing Orders 84.1 and in pursuance of Standing Order 146, Mr. Gautrin, Deputy Government House Leader, moved:

THAT within the framework of the examination of Bill 51, An Act to amend the Animal Health Protection Act mainly in regard to animal safety and welfare, the Committee on Agriculture, Fisheries, Energy and Natural Resources hold special consultations and public hearings on 28 and 29 May 2012, and that, for this purpose, it hear the following groups:

The presentation by each group shall last no more than 10 minutes and the exchange with the members of the Committee shall last no more than 35 minutes, which time shall be shared equally among the members of the parliamentary group forming the Government and the Members sitting in opposition;

A period of 15 minutes shall be allotted for the closing statements, which time shall be shared equally among the members of the parliamentary group forming the Government and the Members sitting in opposition;

The Minister of Agriculture, Fisheries and Food shall be a member of the said Committee during its proceedings with respect to this order of reference.

The motion was carried.
