A period of 15 minutes shall be allotted for the closing statements, which time shall be shared equally among the members of the parliamentary group forming the Government and the Members sitting in opposition;

The Minister of Families shall be a member of the said Committee during its proceedings with respect to this order of reference.

Government Bills

Report Stage

The Assembly took into consideration the report from the Committee on Institutions on its clause-by-clause consideration of Bill 75, An Act respecting certain powers of inspection and seizure.

After debate thereon, the report was concurred in.

Passage

Mr. Bolduc, Minister of Health and Social Services, moved the passage of Bill 74, An Act to prevent skin cancer caused by artificial tanning.

After debate thereon, the motion was carried and, accordingly, Bill 74 was passed.

At 3.57 o'clock p.m., at the request of Mr. Dutil, Deputy Government House Leader, Mrs. Houda-Pepin, First Vice-President, suspended the proceedings until 4.30 o'clock p.m.

Passage in Principle

Mrs. St-Pierre, Minister of Culture, Communications and the Status of Women, moved, –That Bill 76, An Act to amend the Act respecting the Société de développement des entreprises culturelles, do now pass in principle.

After debate thereon, the motion was carried and Bill 76 was accordingly passed in principle.
