Oral Questions and Answers

The Assembly proceeded to Oral Question Period.

At the request of Mr. President, Mr. Fournier, Leader of the Official Opposition, twice withdrew certain words deemed unparliamentary.

Deferred Divisions

The Assembly took the division, which had been deferred at the sitting of 21 November 2012, on the motion moved by Mrs. James (Nelligan) during Business Standing in the Name of Members in Opposition.

This motion reads as follows:

THAT the National Assembly instruct the Committee on Transportation and the Environment to shed light on the events of last 24 October concerning the action taken by the Minister of Sustainable Development, Environment, Wildlife and Parks with regard to the independent public body known as the Bureau d'audiences publiques sur l'environnement (BAPE);

THAT, for this purpose, the Committee hear the Minister of Sustainable Development, Environment, Wildlife and Parks as soon as possible, as well as any person it shall deem necessary to summon without compromising the independence of the BAPE;

THAT the presentation by the Minister of Sustainable Development, Environment, Wildlife and Parks last no longer than 10 minutes and the exchanges with the Committee members last no longer than 120 minutes;

THAT the presentation by each of the other speakers last no longer than 10 minutes and the exchanges with the Committee members last no longer than 50 minutes; THAT the Committee report to the Assembly no later than Friday, 7 December 2012, unless the Committee decides otherwise;

Lastly, that this motion become an order of the Assembly.

Motions Without Notice

Mr. Traversy (Terrebonne) moved a motion concerning the examination of a draft regulation in committee; this motion could not be debated for want of unanimous consent.

By leave of the Assembly to set aside Standing Order 185, Mrs. Blais (Saint-Henri–Sainte-Anne), together with Mr. Hébert, Minister of Health and Social Services, Mrs. Daneault (Groulx) and Mrs. David (Gouin), moved:

THAT the National Assembly underline the presence of representatives of the Federation of Québec Alzheimer Societies and of its twenty regional Alzheimer Societies, within the framework of their fifth day to raise the awareness of Québec parliamentarians;

We underline that the Alzheimer Societies, through the services they provide, truly make a difference in the personal and social lives of those persons touched by Alzheimer's disease and related disorders.

By leave of the Assembly, the motion was carried.

Mrs. Roy (Montarville), together with Mr. Bachand (Outremont), moved a motion concerning the 2013-2014 Budget; this motion could not be debated for want of unanimous consent.

By leave of the Assembly to set aside Standing Orders 84.1 and 185, Mr. Cloutier, Minister responsible for Canadian Intergovernmental Affairs and Sovereignist Governance, together with Mr. Bachand (Outremont), Mr. Caire (La Peltrie) and Mrs. David (Gouin), moved:

THAT the National Assembly demand that the federal government abandon the plan to create a Canada-wide securities regulator;

THAT it call upon the federal government to comply with the unanimous judgment of the Supreme Court of Canada, which, on 22 December 2011, ruled that the proposed federal Securities Act is unconstitutional;

THAT it affirm Québec's willingness to continue working with the Canadian provinces towards harmonizing securities regulations.

By leave of the Assembly, the motion was carried.

Business Having Precedence

Debate on the Budget Speech

The Assembly entered upon the debate on the motion by Mr. Marceau, Minister of Finance and the Economy, –That this Assembly approves in general the budgetary policy of the Government.

At the request of Mrs. Poirier, First Vice-President, Mr. Legault, Leader of the Second Opposition Group, withdrew certain words deemed unparliamentary.

22 November 2012

Mrs. Poirier, First Vice-President, interrupted the debate and informed the Assembly of the allocation of speaking time for this debate: 5 hours 46 minutes 50 seconds shall be set aside for the group forming the Government, including the Budget Speech; 5 hours 21 minutes 8 seconds shall be set aside for the group forming the Official Opposition, including the comments made by the representative of the Official Opposition on Tuesday, 20 November 2012, and his address on Thursday, 22 November 2012; 2 hours 2 minutes 2 seconds shall be set aside for the Second Opposition Group, including the comments made by the representative of the Second Opposition Group on Tuesday, 20 November 2012; and the address by the Leader of the Second Opposition Group on Tuesday, 22 November 2012; 20 minutes shall be set aside for the independent Members. Within this framework, any time not used by the independent Members or by any of the parliamentary groups shall be redistributed among the parliamentary groups in proportion to their representation in the Assembly. Lastly, individual addresses shall not be limited.

The debate continued.

At 12.59 o'clock p.m., Mrs. Poirier, First Vice-President, suspended the proceedings until 3.00 o'clock p.m.

The proceedings resumed at 3.00 o'clock p.m.

Debate on the Budget Speech

The Assembly continued the debate on the motion by Mr. Marceau, Minister of Finance and the Economy, –That this Assembly approves in general the budgetary policy of the Government.

At the end of her speech, Mrs. David (Gouin) moved the following motion stating a grievance:

THAT the National Assembly severely blame the Parti Québécois Government for its 2013-2014 budget, since the budget direction does not allow for raising the revenues necessary to achieve a balanced budget in the short term and since this direction does not support greater social justice for all the citizens of Québec.

The debate continued, subject to the receivability of this motion.

Debates Upon Adjournment

The Assembly held two debates upon adjournment:

- the first, on a question by Mr. Dubourg (Viau) to Mr. Marceau, Minister of Finance and the Economy, about the increase in the tobacco tax;
- the second, on a question by Mr. Bolduc (Jean-Talon) to Mr. Hébert, Minister of Health and Social Services, about the agreements signed with the two medical federations.

At 6.22 o'clock p.m., Mr. Cousineau, Second Vice-President, adjourned the Assembly until Tuesday, 27 November 2012, at 1.45 o'clock p.m.
