The Assembly proceeded to Oral Question Period.

Motions Without Notice

By leave of the Assembly to set aside Standing Order 185, Mrs. Daneault (Groulx), together with Mrs. Malavoy, Minister of Education, Recreation and Sports, Mr. Bolduc (Jean-Talon) and Mr. Khadir (Mercier), moved:

THAT the National Assembly underline the 5/30 Health and Wellness Challenge, which will be held throughout Québec from 1 March to 11 April 2013;

THAT it recall the importance of combining physical activity with healthy eating by inviting its Members, along with their fellow citizens, to register for the Health and Wellness Challenge and to maintain an active and healthy lifestyle.

By leave of the Assembly, the motion was carried.

By leave of the Assembly to set aside Standing Order 185, Mr. Drainville, Minister responsible for Democratic Institutions and Active Citizenship, together with Mrs. de Santis (Bourassa-Sauvé), Mr. Gautrin (Verdun), Mr. Deltell (Chauveau) and Mr. Khadir (Mercier), moved:

> THAT the National Assembly underline the International Open Data Day, which will be held next 23 February;

> THAT it recognize the fundamental contribution of open data to breathe new life into Québec democracy and to encourage citizen participation;

THAT it commend this initiative, which contributes to providing citizens with the tools to allow them to play a more active role in society and which fosters the free flow of information in the best interests of society.

By leave of the Assembly, the motion was carried.

Mr. Khadir (Mercier) moved:

THAT, on this day following World Day of Social Justice, as proclaimed by the General Assembly of the United Nations (UN), the National Assembly endorse the declaration of the UN Secretary General, who invites UN member States to intensify their "efforts to achieve a more inclusive, equitable and sustainable development path built on dialogue, transparency and social justice";

THAT the National Assembly recognize that social justice rests on financial equity, and invite the Government to follow the recommendations of the OECD, which urges governments to find "solutions to ensure that tax systems do not unduly favour multinational enterprises, leaving citizens and small businesses with bigger tax bills".

By leave of the Assembly, the motion was carried.

By leave of the Assembly to set aside Standing Order 84.1 and pursuant to Standing Order 146, Mr. Traversy, Deputy Government House Leader, moved:

THAT, within the framework of the examination of Bill 17, An Act to amend the Professional Code with respect to disciplinary justice, the Committee on Institutions hold special consultations and public hearings next 15 and 18 March and that, for this purpose, it hear the following groups: Ordre des professions du Québec Ordres des ingénieurs du Québec Ordre des comptables professionnels agréés du Québec Conseil interprofessionnel du Québec Barreau du Québec Chambre des notaires

THAT a period of 15 minutes be set aside for opening statements;

THAT the time set aside for the opening statements by the party forming the Government and by the party forming the Official Opposition be of 6 minutes each and the time set aside for the Second Opposition Group be of 3 minutes;

THAT the presentation of each of the groups last no longer than 10 minutes and the exchange with the Committee members last no longer than 50 minutes;

THAT the time set aside for the party forming the Government be of 24 minutes and the time set aside for the opposition Members be of 26 minutes;

THAT a period of 15 minutes be set aside for closing statements allocated in the same manner as for the opening statements;

THAT the Minister of Justice be a member of the said Committee during its proceedings with respect to this order of reference.

By leave of the Assembly, the motion was carried.

By leave of the Assembly to set aside Standing Order 84.1 and pursuant to Standing Order 146, Mr. Traversy, Deputy Government House Leader, moved:

THAT, in pursuance of section 179 of the Act respecting Access to documents held by public bodies and the Protection of personal information, the Committee on Institutions hold a general consultation and public hearings beginning on 9 April 2013;

THAT all briefs and requests to be heard be received by the clerk of the Committee on Institutions no later than 30 March 2013;

THAT the Minister responsible for Democratic Institutions and Active Citizenship be a member of the said Committee during its proceedings with respect to this order of reference.

By leave of the Assembly, the motion was carried.

Mr. Traversy, Deputy Government House Leader, convened the following Committees:

Business Having Precedence

Estimates of Expenditure

The Assembly entered upon the limited debate on the reports from the committees that considered the estimates of expenditure of the departments for the fiscal year ending on 31 March 2014.

Mrs. Poirier, First Vice-President, informed the Assembly of the allocation of speaking time for this limited debate: 50 minutes 29 seconds shall be allotted to the parliamentary group forming the Government; 46 minutes 45 seconds shall be allotted to the parliamentary group forming the Official Opposition; 17 minutes 46 seconds shall be allotted to the independent Members. Within this framework, any time not used by the independent Members or by any of the parliamentary groups shall be redistributed among the parliamentary groups in proportion to their representation in the Assembly. Lastly, individual addresses shall not be limited.

The debate arose thereon.

By leave of the Assembly to set aside Standing Orders 53 and 59, Mr. Dubé (Lévis) tabled the following:

The debate continued.

By leave of the Assembly to set aside Standing Order 20, the proceedings continued beyond 1.00 o'clock p.m.

The debate being concluded and the Assembly having disposed of the motion stating a grievance and the motion by the Minister of Finance and the Economy, —That this Assembly approves in general the budgetary policy of the Government, moved within the framework of the Budget Speech, the question was put for concurrence in the reports from the committees that considered the estimates of expenditure of the several departments for the fiscal year ending on 31 March 2014; a recorded division was thereupon demanded.

Government Bills

Passage in Principle

The Assembly resumed the debate, which had been adjourned on 20 February 2013, on the motion by Mrs. Ouellet, Minister of Natural Resources, for the passage in principle of Bill 7, An Act to amend the Sustainable Forest Development Act and other legislative provisions.

The debate being concluded, the motion was carried and Bill 7 was accordingly passed in principle.

Mr. Traversy, Deputy Government House Leader, moved that Bill 7 be referred for clause-by-clause consideration to the Committee on Agriculture, Fisheries, Energy and Natural Resources.

The motion was carried.

At 3.07 o'clock p.m., at the request of Mr. Traversy, Deputy Government House Leader, Mr. Cousineau, Second Vice-President, suspended the proceedings until 5.30 o'clock p.m.

The proceedings resumed at 5.31 o'clock p.m.

Debates Upon Adjournment

By leave of the Assembly to set aside Standing Order 309, the Assembly held two debates upon adjournment:

- the first, on a question by Mr. Kelley (Jacques-Cartier) to Mrs. Marois, Premier, about consultations with the First Nations regarding the cancellation of mini hydro-electric projects. Mrs. Larouche, Minister for Aboriginal Affairs, replaced the Premier for this debate;
- the second, on a question by Mrs. Vallée (Gatineau) to Mr. Hébert, Minister of Health and Social Services, about ambulance coverage in the Outaouais region.

By leave of the Assembly to set aside Standing Order 308, the debate upon adjournment between Mr. Hamad (Louis-Hébert) and Mr. Duchesne, Minister of Higher Education, Research, Science and Technology, about the letter addressed to the deputy minister at the Ministère de l'Éducation, du Loisir et du Sport from the secretary and chief information officer at the Secrétariat du Conseil du trésor, was deferred until Tuesday, 12 March 2013.

At 5.56 o'clock p.m., Mr. Ouimet, Third Vice-President, adjourned the Assembly until Tuesday, 12 March 2013, at 1.45 o'clock p.m.
