Complaints of Breach of Privilege or Contempt and Personal Explanations

Mr. President handed down a ruling on the point of privilege raised by the Second Opposition Group House Leader on 28 May 2013, in which he submitted that a breach of privilege arose from advertising messages and information disseminated by several school boards inviting parents to register their children for full-time kindergarten for 4-year-olds in September 2013, while Bill 23, An Act to amend the Education Act concerning certain educational services for students under five years of age, is still under consideration at the National Assembly.

RULING FROM THE CHAIR

It has already been established by jurisprudence that acting on legislative provisions still under consideration at the National Assembly may constitute contempt of Parliament. In this particular case, to determine whether the school boards have committed prima facie contempt of Parliament, the Chair must assess whether the advertising and information in question discredit the role of the Assembly and its Members.

Everything indicates that, in setting up a full-time kindergarten program for 4-year-olds, the school boards concerned are indeed acting on the provisions of Bill 23. However, none of the messages or information disseminated refer to the role of the Assembly or its Members in connection with the passage of Bill 23.

As regards Commission scolaire de Rouyn-Noranda, it cannot clearly be inferred from the wording used in its press release that Bill 23 is in force. The Chair would therefore be hard pressed to conclude that the school board committed *prima facie* contempt of Parliament by issuing the press release since the press release does not suggest that Bill 23 has immediate force of law. It would, however, have been preferable for the school board to refer to Bill 23 and the Assembly's role in the press release and thus show greater concern for clarity for the public's sake and greater deference to the Assembly and its Members.

The situation is different for Commission scolaire des Chênes and Commission scolaire de la Vallée-des-Tisserands. The information disseminated by these school boards readily suggests that kindergarten programs for 4-year-olds are already in place within their schools and, consequently, that the provisions of Bill 23 under which these programs may be offered are in immediate effect. No reference is made to the Assembly's role as regards discussing and passing Bill 23. The Chair must therefore find that these two school boards have committed *prima facie* contempt of Parliament.

In light of this, the Chair would issue a reminder about the importance of including an explicit reference to the role of the Assembly and its Members in any advertising or communication of information about a measure provided for in a bill under consideration at the Assembly. It should be clearly stated that the planned measures will be implemented subject to passage of the bill by the National Assembly.

Lastly, the Chair indicated that it is now for the Second Opposition Group House Leader to establish whether he wishes to continue the procedure and move the motions as required by Standing Order 324.

Following the decision given by the President, Mr. Deltell, Second Opposition Group House Leader, indicated that in the event that both school boards acknowledged their mistake by sending a letter to that effect to the Assembly, the matter would be considered closed.
