By leave of the Assembly to set aside Standing Order 185, Mrs. Maltais, Minister responsible for the Capitale-Nationale region, together with Mr. Moreau (Châteauguay), Mr. Deltell (Chauveau) and Mr. Ratthé (Blainville), moved:

THAT the National Assembly underline the centennial year of the creation of the Royal 22nd Regiment;

THAT it underline the heritage and contribution of this institution to the outreach and protection of the French language;

THAT it also underline the courage and sense of duty of the men and women who have made it famous.

By leave of the Assembly to set aside Standing Orders 53 and 59, Mr. Moreau, Official Opposition House Leader, tabled the following:

She then informed the Assembly that on Friday, 1 November 2013, Mr. Ouimet (Fabre) would question Mr. St-Arnaud, Minister of Justice, during an interpellation on "the Parti Québécois Government's refusal to release all of the legal opinions concerning the Government's policy directions with regard to its Charter of Québec Values".

Government Bills

Passage in Principle

The Assembly resumed the debate, which had been adjourned on 23 October 2013, on the motion by Mrs. Hivon, Minister for Social Services and Youth Protection, for the passage in principle of Bill 52, An Act respecting end-of-life care.

At 1.00 o'clock p.m., Mrs. Poirier, First Vice-President, suspended the proceedings until 3.00 o'clock p.m.

The proceedings resumed at 3.00 o'clock p.m.

Passage in Principle

The Assembly continued the debate on the motion by Mrs. Hivon, Minister for Social Services and Youth Protection, for the passage in principle of Bill 52, An Act respecting end-of-life care.

The debate being concluded, the question was put on this motion; a recorded division was thereupon demanded.

At the request of Mr. Traversy, Deputy Government House Leader, the division was deferred until Routine Proceedings on the next sitting day.

Government Motions

The Assembly held the debate on the motion arising out of the tabling by Mr. Lisée, Minister of International Relations, La Francophonie and External Trade, on 12 June 2013, of the Convention on the Settlement of Investment Disputes between States and Nationals of Other States.

This motion reads as follows:

THAT, in accordance with section 22.3 of the *Act respecting the Ministère des Relations internationales*, the National Assembly examine, within the time limit set out by the Act and for its approval, the Convention on the Settlement of Investment Disputes between States and Nationals of Other States.

Mr. Cousineau, Second Vice-President, informed the Assembly of the allocation of speaking time for the proceedings with respect to this limited debate: 51 minutes 18 seconds shall be allotted to the parliamentary group forming the Government; 45 minutes 36 seconds shall be allotted to the parliamentary group forming the Official Opposition; 17 minutes 6 seconds shall be allotted to the Second Opposition Group; and 6 minutes shall be allotted to the independent Members. Within this framework, any time not used by the independent Members or by any of the parliamentary groups shall be redistributed among the parliamentary groups in proportion to their representation in the Assembly. Lastly, individual addresses shall not be limited.
