Motions Without Notice

Mrs. Roy (Montarville) moved a motion concerning the regulation of retail prices of new printed and digital books; this motion could not be debated for want of unanimous consent.

By leave of the Assembly to set aside Standing Order 185, Mr. Lisée, Minister of International Relations, La Francophonie and External Trade, together with Mr. Le Bouyonnec (La Prairie) and Mrs. David (Gouin), moved:

THAT the National Assembly, in support of the Association québécoise des organismes de coopération internationale, express its deep concern concerning the delay, by the federal authorities in charge of international development, in launching calls for proposals on voluntary cooperation, international development and international youth internships, delays which could lead to the unnecessary return of hundreds of cooperants involved in actions of solidarity, to the dismantlement of infrastructures that were patiently built by Québec organizations in several southern countries, to the reduction or end of several growth-generating projects as well as the annual involvement of close to one hundred young Québec interns in humanitarian action;

THAT it ask that the calls for proposals within the framework of these programs be launched without delay, as they are vital to the action, and in certain cases to the survival, of Québec international cooperation organizations.

By leave of the Assembly, the motion was carried.

By leave of the Assembly to set aside Standing Order 185, Mrs. Blais (Saint-Henri-Sainte-Anne), together with Mr. Hébert, Minister of Health and Social Services, Mrs. Roy (Arthabaska) and Mrs. David (Gouin), moved:

THAT the National Assembly underline Annual Caregivers' Week, which was unanimously recognized by the National Assembly in 2007, at the request of Mrs. Lucy Barylak, of the Cavendish Health and Social Services Centre;

THAT it underline the admirable and essential work carried out each day by caregivers;

THAT it reaffirm its desire to adequately support them, to recognize and value their role as well as their outstanding contribution to our society.

Mrs. Maltais, Minister responsible for the Capitale-Nationale region, replaced the Minister of Sustainable Development, Environment, Wildlife and Parks, for this debate.

At the request of Mrs. Poirier, First Vice-President, Mr. Drolet (Jean-Lesage) withdrew certain words deemed unparliamentary.

At 6.13 o'clock p.m., Mrs. Poirier, First Vice-President, adjourned the Assembly until Tuesday, 5 November 2013, at 1.45 o'clock p.m.
