## Introduction of Bills

Mr. Coiteux, Minister responsible for Government Administration and Ongoing Program Review and Chair of the Conseil du trésor, moved that leave be granted to introduce the following Bill:
$4 \quad$ An Act to amend the Act authorizing the making of collective agreements with a term of more than three years in the public and parapublic sectors

The motion was carried.

Accordingly, Bill 4 was introduced in the Assembly.

## Presenting Papers

Mr. President gave a directive on the management of question period and the distribution of measures and speaking times for the Forty-First Legislature.

## DIRECTIVE FROM THE CHAIR

As regards business standing in the name of Members in opposition and interpellations, the Official Opposition will have six of these measures per cycle of 10 , including the first of each sessional period. The Members of the Second Opposition Group will be allowed four of these measures per cycle of 10 . For their part, the Members of Québec Solidaire together will be allowed one item of business standing in the name of Members in opposition and one interpellation per parliamentary year, but never during the same sessional period. As was the case previously, these measures allotted to the Members of Québec Solidaire will not count as part of the cycles.

With regard to debates upon adjournment, the Official Opposition will be allowed two debates per sitting during which such debates may be requested, and the Second Opposition Group will be allowed one debate. The Members of Québec Solidaire will each be allowed to request a debate upon adjournment per sessional period. Government Members may request a debate upon adjournment per six sittings during which such debates may be held. These rights will be distributed in this manner only to the extent that the Chair receives several requests and it must determine the order thereof.

Unlike the previous measures, statements by Members are not Government control measures. Instead, they allow all Members to express their views on issues that are of importance to them and that, in most cases, directly concern their fellow citizens. Hence, in the absence of any agreement to the contrary, the distribution of statements by Members must take into account some degree of proportionality to allow everyone, including Ministers who are Members first and foremost, to equitably exercise their rights. Consequently, the parliamentary group forming the Government, that forming the Official Opposition, and the Second Opposition Group will respectively be entitled to five, three and two statements per sitting, subject to the following rules. To reflect proportionality, the parliamentary group forming the Government will also be allowed four additional statements per cycle of nine sittings, in substitution for two statements by the Official Opposition and two statements by the Second Opposition Group. The Members of Québec Solidaire, for their part, will each be allowed one statement per cycle of nine sittings in substitution for a statement by the Official Opposition.

Regarding speaking times for limited debates, the total time allotted to the Members of Québec Solidaire will vary depending on the length of the debate. These Members may decide on the manner in which this time will be used. Half of the remaining time will be granted to the parliamentary group forming the Government and the other half will be distributed among the parliamentary groups in opposition in proportion to the number of seats they hold in the House. Any time that has not been used will be transferred to the parliamentary groups according to the same distribution.

Concerning the management of question period, parliamentary jurisprudence has also, over the years, adopted major principles that must be observed. These principles indicate that it is important to take into account the composition of the Assembly so that each group and each Member may take part in this important exercise of parliamentary control. Each parliamentary group in opposition will be entitled alternately to a set of three consecutive questions, while giving the Official Opposition priority with regard to the possibility of exercising this right, owing to the preponderant status conferred upon it. These sets of three consecutive questions for the parliamentary groups will foster better parliamentary control, by allowing them to enjoy a significant amount of time during question period. This is how it will actually play out.

The preponderant role that the Official Opposition has traditionally enjoyed confers upon it the right to ask the first two main questions at every sitting. The Official Opposition will also be allowed to ask the third main question during the first, third, fifth and seventh sittings of a cycle, thus giving it a set of three consecutive questions during four sittings per cycle. The first question by the Leader of the Official Opposition, regardless of rank, may be followed by three supplementary questions. All other main questions may be followed by only two supplementary questions. Furthermore, the Leader of the Official Opposition will be entitled to 1 minute 30 seconds to ask his main questions.

The Second Opposition Group will be allowed three sets of three consecutive questions during a cycle, namely the third, fourth and fifth questions. This set of three consecutive questions may be exercised during the second, fourth and sixth sittings of the cycle. Moreover, just as for the Leader of the Official Opposition, the Leader of the Second Opposition Group will also be entitled to 1 minute 30 seconds to ask his main questions.

The sixth and seventh questions will be granted to the Official Opposition, subject to three questions per cycle that may be asked by the Members of Québec Solidaire in seventh place, at any sitting of a cycle. Though the Members of Québec Solidaire do not form a parliamentary group under our Standing Orders, the Chair cannot ignore the fact that all three Members represent the same political party. As in the past, the Chair cannot deny this political affiliation and will therefore allow these Members to transfer their right to ask a question among themselves. This will also be the case with regard to all other measures conferred upon the Members of Québec Solidaire.

The eighth question will be granted to the Second Opposition Group while the ninth will be granted to the Official Opposition. Beginning at the tenth question, the Members of the Official Opposition and those of the Second Opposition Group will alternate at each sitting, as indicated in the document tabled.

As regards the Government Members, parliamentary jurisprudence also clearly confers upon them the right to ask questions. They will therefore be allowed to ask three questions per cycle of seven sittings in sixth and eighth places, in substitution alternately for a question by the Official Opposition or by the Second Opposition Group.

Lastly, the main questions that will not be asked by the leader of a parliamentary group will last no longer than 1 minute, and the supplementary questions, 30 seconds. The Premier's replies to the main questions will last 1 minute 45 seconds. The other ministers' replies to the main questions will last no longer than 1 minute 15 seconds, and replies to supplementary questions will last 45 seconds.

Tables indicating the distribution of measures and speaking times will be tabled. This distribution is deemed to be part of this directive.

As for the membership of the standing committees, the Chair asks that discussions continue with regard to the forming of these committees and that the Assembly's composition be taken into account.
