Motions Without Notice

By leave of the Assembly to set aside Standing Order 185, Mrs. David, Minister of Culture and Communications, together with Mrs. Hivon (Joliette), Mrs. Samson (Iberville) and Mr. Khadir (Mercier), moved:

THAT the National Assembly congratulate the recipients of the Prix du Québec, the most prestigious award attributed by the Government in the fields of culture and science;

THAT it recall that Prix du Québec recipients are women and men who have made a contribution to the individual and collective enrichment of Québec society as well as to Québec's influence around the world.

By leave of the Assembly, the motion was carried.

By leave of the Assembly to set aside Standing Order 185, Mr. Deltell (Chauveau), together with Mr. Hamad, Minister responsible for the Capitale-Nationale region, Mrs. Maltais (Taschereau), Mr. Picard (Chutes-de-la-Chaudière), Mr. Paradis (Lévis) and Mr. Khadir (Mercier), moved:

THAT the National Assembly add its voice to those of the mayors of Québec City and Lévis and ask Canadian National to take its responsibilities regarding the need to repaint and maintain the Québec Bridge properly.

By leave of the Assembly, a debate arose thereon.

The debate being concluded, the motion was carried.

Mr. Khadir (Mercier) moved a motion concerning the Mine Arnaud project in Sept-Îles; this motion could not be debated for want of unanimous consent.

Information on the Proceedings of the Assembly

Mr. Ouimet, First Vice-President, informed the Assembly that on Wednesday, 5 November 2014, during Business Standing in the Name of Members in Opposition, a debate will be held on the motion by Mr. Kotto (Bourget).

This motion reads as follows:

THAT the National Assembly recognize the essential role played by local development centres (CLDs) throughout Québec since 1998;

THAT it recognize that CLDs constitute a model in which local stakeholders, entrepreneurs and elected officials work together to develop their community;

THAT the National Assembly recognize that CLDs constitute a network of experts and contacts to help entrepreneurs with business start-ups and business recoveries;

THAT the National Assembly take note of the 205,000 jobs created or maintained, the 28,000 businesses created or consolidated, and the \$7 billion in investments that CLDs have generated throughout Québec since 1998;

THAT the National Assembly ask the Government to maintain the current CLD model, which provides consistent, professional and independent support to entrepreneurs throughout Québec.

Passage in Principle
