Mr. President communicated to the Assembly and then tabled the report from the Law Clerk on the following private bill:

Motions Without Notice

By leave of the Assembly to set aside Standing Order 185, Mr. Schneeberger (Drummond–Bois-Francs), together with Mrs. Charbonneau, Minister of Families and Minister responsible for Seniors, Mr. Lisée (Rosemont) and Mrs. David (Gouin), moved:

THAT the National Assembly underline World Kindness Day today, 13 November;

THAT the National Assembly recognize the efforts made and the steps taken by the AQDR du Centre-du-Québec and its partners over the past four years by officially recognizing this day.

By leave of the Assembly, the motion was carried.

By leave of the Assembly to set aside Standing Order 185, Mrs. de Santis (Bourassa-Sauvé), together with Mr. Therrien (Sanguinet), Mr. Surprenant (Groulx) and Mrs. David (Gouin), moved:

THAT the National Assembly congratulate the finalists of the Prix reconnaissance of the Forum des jeunes de la fonction publique québécoise, whom we have the pleasure of welcoming in our gallery;

THAT it recognize the involvement of young people aged 35 and under in Québec's civil service and their participation in the evolution of the State, as well as the work of managers who ensure that young people gain visibility and grow within their respective departments and agencies.

By leave of the Assembly, a debate arose thereon.

The debate being concluded, the motion was carried.

By leave of the Assembly to set aside Standing Order 185, Mrs. Ouellet (Vachon), together with Mr. Bonnardel (Granby) and Mrs. Massé (Sainte-Marie-Saint-Jacques), moved:

THAT the National Assembly ask that the name *Champlain* be maintained for the new bridge that will join the South Shore to Montréal.

By leave of the Assembly, the motion was carried.

Mrs. Massé (Sainte-Marie-Saint-Jacques) moved a motion concerning the clause-by-clause consideration of Bill 3, An Act to foster the financial health and sustainability of municipal defined benefit pension plans; this motion could not be debated for want of unanimous consent.

By leave of the Assembly to set aside Standing Orders 84.1 and 185, Mr. Gaudreault (Jonquière), together with Mr. Heurtel, Minister of Sustainable Development, the Environment and the Fight Against Climate Change, Mr. Martel (Nicolet-Bécancour) and Mrs. Massé (Sainte-Marie–Saint-Jacques), moved:

THAT the National Assembly underline the 25th anniversary of the Centre québécois du droit de l'environnement (CQDE);

THAT it stress the active role the CQDE plays within Québec society through its involvement in major current debates on the environment;

THAT it recall that the CQDE offers legal information to citizens and environmental protection groups, thus making it possible for them to understand the legal dimensions of the environmental problems they face;

Lastly, that the National Assembly express its wish that the CQDE continue its longstanding, productive endeavours.

By leave of the Assembly, the motion was carried.

Notices of Proceedings in Committees

Mr. Sklavounos, Deputy Government House Leader, convened the following committees:

- the Committee on Planning and the Public Domain, to continue its clause-by-clause consideration of Bill 3, An Act to foster the financial health and sustainability of municipal defined benefit pension plans;
- the Committee on Agriculture, Fisheries, Energy and Natural Resources, to continue its clause-by-clause consideration of Bill 11, An Act respecting the Société du Plan Nord;
- the Committee on Public Finance, to continue its clause-by-clause consideration of Bill 15, An Act respecting workforce management and control within government departments, public sector bodies and networks and state-owned enterprises;
- the Committee on Institutions, to give clause-by-clause consideration to Bill 17, An Act to amend the Act respecting the Barreau du Québec, the Notaries Act and the Professional Code:
- the Committee on Transportation and the Environment, to hold public hearings within the framework of special consultations on Bill 16, An Act to amend the Act respecting off-highway vehicles and other provisions.

And, by leave of the Assembly to set aside Standing Order 143, he then convened the following committee:

— the Committee on Health and Social Services, to continue its public hearings within the framework of special consultations on Bill 10, An Act to modify the organization and governance of the health and social services network, in particular by abolishing the regional agencies.

Mr. Ouimet, First Vice-President, gave the following notices:

- the Committee on Public Administration shall hold a deliberative meeting to organize its proceedings;
- the Committee on Citizen Relations shall hold a deliberative meeting to discuss the observations and conclusions of the Committee following the hearings on the examination of the activity reports of the Caregiver Support Fund and the Société de gestion L'Appui.

Information on the Proceedings of the Assembly

Mr. Ouimet, First Vice-President, informed the Assembly that on Friday, 21 November 2014, Mrs. Lavallée (Repentigny) would question Mrs. Charbonneau, Minister of Families, during an interpellation about the Liberal Government's lack of vision with regard to the future of the childcare network.

At 11.31 o'clock a.m., at the request of Mr. Sklavounos, Deputy Government House Leader, Mr. Ouimet, First Vice-President, suspended the proceedings until the expiry of the time appointed to receive notices for debates upon adjournment.

The proceedings resumed at 11.41 o'clock a.m.

At 11.42 o'clock a.m., at the request of Mr. Sklavounos, Deputy Government House Leader, Mr. Ouimet, First Vice-President, suspended the proceedings until 6.00 o'clock p.m.

Debates upon adjournment

At 6.04 o'clock p.m., the Assembly held two debates upon adjournment:

— the first, on a question by Mr. Lisée (Rosemont) to Mr. Poëti, Minister responsible for the Montréal region, about maintaining the name *Champlain* for the new bridge that will join the South Shore to Montréal.

At the request of Mr. Ouimet, First Vice-President, Mr. Lisée (Rosemont) withdrew certain words deemed unparliamentary.

— the second, on a question by Mr. Turcotte (Saint-Jean) to Mr. Blais, Minister of Employment and Social Solidarity, concerning the future of youth employment centres and the youth employment situation in Québec.

At 6.28 o'clock p.m., by leave of the Assembly, Mr. Ouimet, First Vice-President, suspended the proceedings until 7.00 o'clock p.m. for the third debate upon adjournment.

At 7.11 o'clock p.m., the Assembly held the third debate upon adjournment on a question by Mr. Paradis (Lévis) to Mr. Barrette, Minister of Health and Social Services, about installing sprinklers in residential and long-term care centres.

Accordingly, at 7.24 o'clock p.m., Mr. Ouimet, First Vice-President, adjourned the Assembly until Tuesday, 18 November 2014, at 1.45 o'clock p.m.
