THAT it underline how his character "Picolo" and his trailer, the companions of both young and old, shall forever live on in the memory of Quebecers;

THAT it also underline his profound attachment and great commitment to Québec;

THAT it convey its condolences to his family, friends, colleagues and many fans throughout Québec.
