Oral Questions and Answers

The Assembly proceeded to Oral Question Period.

Motions Without Notice

Mr. Drainville (Marie-Victorin), together with Mr. Deltell (Chauveau) and Mr. Khadir (Mercier), moved a motion concerning Hydro-Québec; this motion could not be debated for want of unanimous consent.

By leave of the Assembly to set aside Standing Order 185, Mr. Roberge (Chambly), together with Mr. Bolduc, Minister of Education, Recreation and Sports, Mrs. Léger (Pointe-aux-Trembles) and Mrs. David (Gouin), moved:

THAT the National Assembly mark "Hooked on School Days" being held across Québec from 16 to 20 February;

THAT it take this opportunity to acknowledge the work done by all the education system's professionals who, on a daily basis, devote themselves to our young people and help enhance their educational success;

THAT it invite the public to join them and their partners in supporting the numerous projects and initiatives highlighting the importance of student retention.

By leave of the Assembly, a debate arose thereon.

The debate being concluded, the motion was carried.

By leave of the Assembly to set aside Standing Order 185, Mrs. Gaudreault (Hull), together with Mrs. Poirier (Hochelaga-Maisonneuve), Mrs. Roy (Montarville) and Mrs. Massé (Sainte-Marie–Saint-Jacques), moved:

THAT the National Assembly recognize the historic nature of the meeting held within its walls today, 18 February 2015, between the Cercle des femmes parlementaires du Québec (circle of women Members of the National Assembly) and the Elected Women of the Assembly of First Nations of Quebec and Labrador;

That it mark and endorse the signing, by the two groups, of a Solidarity Protocol aimed at creating lasting ties and demonstrating the desire for a respectful dialogue based on values such as sharing, equality, peace and social justice.

By leave of the Assembly, a debate arose thereon.

The debate being concluded, the motion was carried.

Mr. Khadir (Mercier) moved a motion concerning the fight against economic inequality and tax evasion; this motion could not be debated for want of unanimous consent.

Notices of Proceedings in Committees

Mr. Sklavounos, Deputy Government House Leader, convened the following committees:

— the Committee on Institutions, to continue its clause-by-clause consideration of Bill 26, An Act to ensure mainly the recovery of amounts obtained as a result of fraud or fraudulent tactics in connection with public contracts.

Mr. Gendron, Third Vice-President, gave the following notice:

— the Committee on Public Administration shall hold a deliberative meeting to prepare the hearing of the Auditor General on his 2013–2014 annual management report; then, hold a public hearing to hear the Auditor General; and finally, hold a deliberative meeting to discuss the observations, conclusions and recommendations, if any, following this hearing.

ORDERS OF THE DAY

Government Bills

Passage in Principle

The Assembly resumed the debate, which had been adjourned on 17 February 2015, on the motion moved by Mr. Leitão, Minister of Finance, that Bill 28, An Act mainly to implement certain provisions of the Budget Speech of 4 June 2014 and return to a balanced budget in 2015–2016, do now pass in principle.

At 12:59 o'clock p.m., Mr. Gendron, Third Vice-President, suspended the proceedings until 3.00 o'clock p.m.

Accordingly, pursuant to Standing Order 97, the debate on the motion by Mr. Leitão, Minister of Finance, was adjourned in the name of Mrs. Richard (Duplessis).

The proceedings resumed at 3.00 o'clock p.m.

Business Standing in the Name of Members in Opposition

Mrs. Roy (Montarville) moved:

THAT the National Assembly acknowledge that the fundamental freedoms and rights recognized by the Québec *Charter of human rights and freedoms* must be exercised in a manner that is respectful of democratic values, public order and the overall well-being of Québec citizens;

THAT it acknowledge the need, in the face of religious fundamentalism and radicalism, to defend the values the Québec nation has chosen to enshrine in the *Charter of human rights and freedoms*;

THAT it urge the Government to introduce a bill prohibiting expressions that contradict the values set out in the *Charter of human rights and freedoms* by promoting hatred or fostering contempt and marginalization of persons or groups of persons on the basis of any prohibited ground for discrimination;

THAT it urge the Government to introduce a bill allowing the courts to deprive organizations of the tax benefits they enjoy under the *Act respecting municipal taxation* and the *Act respecting the Québec sales tax* if they contravene the values set out in the *Charter of human rights and freedoms*.

Mr. Ouimet, First Vice-President, informed the Assembly of the allocation of speaking time for the proceedings with respect to this limited debate: 10 minutes to the mover of the motion for her reply; approximately 52 minutes to the parliamentary group forming the Government; approximately 29 minutes 34 seconds to the parliamentary group forming the Official Opposition; approximately 22 minutes 26 seconds to the Second Opposition Group; and 6 minutes to the independent Members. Within this framework, any time not used by the independent Members or by any of the parliamentary groups shall be redistributed among the parliamentary groups in the proportions established above. Lastly, individual addresses shall not be limited.

A debate arose thereon.

The debate being concluded, the question was put on this motion, and a recorded division was thereupon demanded.

At the request of Mr. Sklavounos, Deputy Government House Leader, the division was deferred until Routine Proceedings on the next sitting day.

Government Bills

Passage in Principle

The Assembly resumed the debate, which had been adjourned earlier during this sitting, on the motion moved by Mr. Leitão, Minister of Finance, that Bill 28, An Act mainly to implement certain provisions of the Budget Speech of 4 June 2014 and return to a balanced budget in 2015–2016, do now pass in principle.

The debate was adjourned in the name of Mr. Roberge (Chambly).
