**Mace**

Borrowed from the British parliamentary ceremonial, the Mace symbolizes the authority of the National Assembly as well as that of its President. It is placed on the centre table of the Chamber and remains there as long as the President is at his seat.

**Blue flag**

This flower was named the official emblematic flower of Québec in autumn 1999 following the passage of the Act respecting the flag and emblems of Québec.

**Former coat of arms of Québec**

Section of the glass canopy adorning the entrance to the *Le Parlementaire* restaurant. This provincial coat of arms was in effect from 1868 to 1939.

**Bust of Pierre-Joseph-Olivier Chauveau (1820-1890)**

Man of letters and bibliophile, Chauveau was the first Premier of Québec, in office from 1867 to 1873.

## NEW SESSION

The Members of the National Assembly welcomed the Lieutenant-Governor, the Honourable Lise Thibault, for the opening of the Second Session of the Thirty-seventh Legislature, on Tuesday, 14 March 2006.



## SELECT COMMITTEE ON THE ELECTION ACT (SCEA)

The Select Committee on the Election Act was established by the National Assembly in June 2005 for the purpose of examining various matters relating to the voting procedure, the holding of elections and measures promoting the representation of the regions, women, youth, ethnocultural minorities and Native people. For the first time in the history of the Assembly's parliamentary proceedings, a citizens' committee was created to assist the Committee members in carrying out their mandate.



## COMMITTEE ON CULTURE CONCERNING THE RELIGIOUS HERITAGE

The Member for Shefford, Mr. Bernard Brodeur, and the Member for Mercier, Mr. Daniel Turp, during the public consultations on the religious heritage. The Committee on Culture held a general consultation in seven cities of Québec.







#### **PRESIDENT'S TOUR**

During winter 2006, the President of the National Assembly, Mr. Michel Bissonnet, conducted a tour of 14 high schools. His visit enabled over 5000 students to have a better understanding of the role of the National Assembly, its history and achievements.

#### **EASTERN REGIONAL CONFERENCE (ERC)**

The National Assembly is an international associated member of the Council of State Governments (CSG) and of its Eastern chapter, the Eastern Regional Conference (ERC). In January 2006, William Cusano, the First Vice-President of the National Assembly was appointed Vice-Chairman of the ERC. It is the first time that a Member outside of the United States holds this prestigious office.

# Preface



I am pleased to present to you the *Activity Report of the National Assembly of Québec for 2005-2006*. Several events have marked the parliamentary year of our institution. First and foremost, let us mention the opening of the Second Session of the 37<sup>th</sup> Legislature on Tuesday, 14 March 2006. It is during this first sitting that the Assembly welcomed the two new Members who were elected in the by-elections held on 12 December 2005, in the electoral divisions of Outremont and Verchères.

In the course of the last year, two parliamentary committees held general consultations in several regions of Québec with respect to the religious heritage issue and the reform of the Election Act. Moreover, they aroused much interest among the population of Québec. This type of consultation had not taken place in 20 years.

The National Assembly continued its analysis of the parliamentary reform proposals tabled in 2004-2005. Several elements were examined by the Standing Subcommittee on Parliamentary Reform, more particularly the parliamentary calendar and schedule, the follow-up to petitions, and citizen participation to the committee proceedings via videoconferencing or on-line consultations.

Furthermore, I had the pleasure of conducting, for a third consecutive year, a tour of Québec high schools in order to better acquaint our young people with the role of the National Assembly. This tour enabled me to share my passion of politics with them, but also to make them discover the thousand and one aspects of our parliamentary life.

As regards interparliamentary and international relations in 2005-2006, the activities were numerous and fruitful. With respect to the parliamentary francophonie, a member of our Assembly represented the Parliamentary Assembly of the Francophonie (APF) at the 33rd Session of the General Conference of UNESCO in Paris, in October 2005. Incidentally, it is on this occasion that the conference members adopted the Preliminary Draft Convention on the Protection and Promotion of the Diversity of Cultural Expressions. The National Assembly also welcomed the Presiding Officer of the Scottish Parliament, the Right Honourable George Reid, and a delegation of Scottish parliamentarians to mark Tartan Day.

I hope that reading this Report will enable you to discover and appreciate the abundant wealth of our parliamentary world.

# Foreword

I am happy to join the President in providing you with an overview of the numerous achievements of the parliamentarians and the administrative personnel in 2005-2006. This document will enable you to discover several aspects of our institution, whether concerning parliamentary work, citizen-oriented activities, diplomacy, the heritage or the administration.

Firstly, I would like to emphasize that parliamentary activities during the past year were abundant. The coordination of two travelling parliamentary committees required the sustained efforts of the personnel of Assembly. On the basis of the results obtained, these consultations were tremendously successful. In total, 102 persons and organizations were heard during the public consultations on the religious heritage, which were held in autumn 2005 in seven cities of Québec. For its part, the Select Committee on the Election Act went above all expectations, as 361 submissions were received during the general consultation. Over 300 persons and organizations were able to be heard during the public hearings, held between the months of January and March 2006 in 16 cities of Québec.

The National Assembly took another step on the environmental scene by launching, in autumn 2005, an important awareness campaign entitled *Pour l'avenir, je récupère!* (*For the future, I'm recycling*). With an earnest desire to further contribute to the conservation of Québec's natural resources, the institution has resolutely committed itself to recycling.

I therefore invite you to read this Activity Report, which will be a valuable guide in reaching a clearer understanding of the operation of our institution, whose role is paramount within our democratic society.

# THE NATIONAL ASSEMBLY



## ITS MISSION

The National Assembly of Québec constitutes the foundation of the legislative power. It is composed of the Members elected by the population of Québec in each of the 125 electoral divisions. The responsibility of debating and passing bills and the budget lies with the Members. They also have the role of supervising the actions of the Government, particularly during Oral Questions and Answers and during the consideration of the Government's estimates of expenditure, and of discussing matters of public interest.

The duration of the collective mandate of these Members, which is called a «legislature», is provided for in the Constitution and cannot exceed five years.

The National Assembly and the Lieutenant-Governor form the Parliament of Québec. The Parliament of Québec assumes all the powers conferred on the Legislature of Québec (*An Act respecting the National Assembly*).

### OPENING SITTING OF THE SECOND SESSION OF THE 37<sup>th</sup> LEGISLATURE

On 10 March 2006, as notified by the Executive Council, the Lieutenant-Governor prorogued the First Session of the Thirty-seventh Legislature and summoned the National Assembly for the opening of the Second Session of the Thirty-seventh Legislature, on Tuesday, 14 March 2006, at 2.00 o'clock p.m.

The Members of the Assembly welcomed the Lieutenant-Governor, the Honourable Lise Thibault. The speech by the Lieutenant-Governor was followed by the opening speech delivered by the Premier, in which he announced the legislative intentions of his Government and the programme he intended to submit to the Assembly in the course of the new session.



## THE THREE POWERS OF THE QUÉBEC STATE

### LEGISLATIVE POWER

Examines, discusses, amends and passes laws.

Supervises the action of the executive power.  
Discusses matters of public interest.



**Parliament**

### EXECUTIVE POWER

Determines policies to guide the actions of the State.

Administers and controls the State in accordance with the laws passed by the legislative power.



**Government**

### JUDICIAL POWER

Interprets the laws passed by the legislative power.

Decides whether a citizen or a group has acted in accordance with the law.



**Courts**

A SESSION is a period of time that elapses between the summoning of the National Assembly and its prorogation. A session is officially open only after the delivery of the Lieutenant-Governor's speech; the Lieutenant-Governor takes the President's Chair on this occasion. The Standing Orders do not provide for any time limit with regard to this speech.

### The role of the Member

The primary activity of the Member is his participation in the legislative process. As a **legislator**, he examines, analyzes and votes on bills at the National Assembly. This role is carried out in several stages, both in the Assembly and in the standing committees.

Furthermore, as the **controller** of the Government's activities, the Member disposes of several methods to scrutinize the actions of the Government. It should be mentioned, among other methods, the interrogation of Ministers on topics of current interest during Oral Question Period, as well as the examination of the activities and management of ministries in committee. He plays a more active part during public hearings in parliamentary committee with regard to the main societal issues.

He also exercises the role of **intermediary** between his constituents and the public administration. The Member represents the constituents of his electoral division. He defends the interests of his fellow citizens and explains their needs to the Government machinery.

### THE MEMBERS OF THE 37<sup>th</sup> LEGISLATURE

#### *The by-elections held on 12 December 2005*

*A by-election* is held in an electoral division to fill a vacancy arising from the resignation or death of a Member or stemming from a judicial ruling. Where the seat of a Member becomes vacant, a Government order instituting the holding of a by-election must be addressed to the Chief Electoral Officer of Québec not later than six months after it becomes vacant.

On 6 June 2005, Mrs. Louise Harel, the Member for Hochelaga-Maisonneuve, was appointed Leader of the Official Opposition by the Parti Québécois caucus members

Following the resignation of four Members in 2005-2006, by-elections were held on 12 December 2005 in the electoral divisions of Outremont and Verchères. These by-elections were called in pursuance of a Government order issued on 8 November 2005. The two remaining by-elections will be held during the year 2006.

On 20 December 2005, the Chief Electoral Officer of Québec transmitted to the Secretary General of the Assembly the list of the candidates declared elected in the following electoral divisions:

\*Independent Members. A parliamentary group is defined as follows: any group of not fewer than 12 Members returned to the Assembly by the same political party or that shall have received not less than 20 % of the popular vote in the most recent general election.

There are 16 former mayors among the current Members.

The Members of the Thirty-seventh Legislature have on average 8 years and 3 months of parliamentary experience. As at 31 March 2006, the average age of Members was 51 years and 7 months. The youngest Member was 26 years of age and the eldest, 70 years of age.

### *Who are our Members?*

As at 31 March 2006, women, of whom there are 39, occupied 31.7 % of the seats in the National Assembly.

As a reflection of Québec's population, the Members of the National Assembly hail from various professional and academic backgrounds.

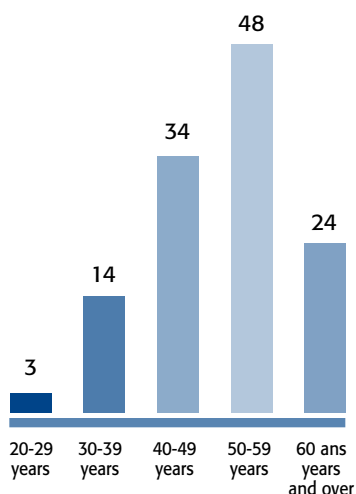
#### PRINCIPAL PROFESSIONAL OCCUPATIONS OF MEMBERS IN THE COURSE OF THEIR CAREER

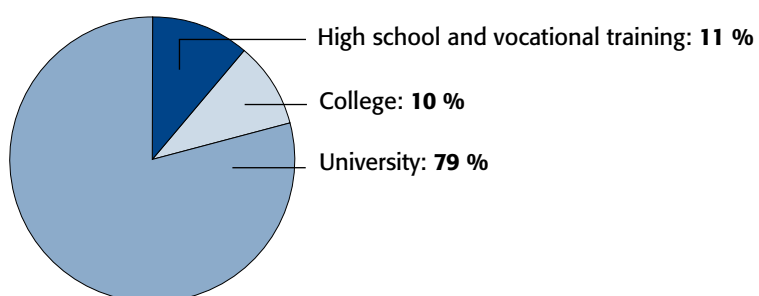
#### AMONG THE MOST PREVALENT UNIVERSITY DISCIPLINES ARE

## **THE SEATING PLAN OF THE ASSEMBLY AS AT 31 MARCH 2006**

### **Parliamentary duties**

#### **President**

He is elected among the Members and his duties are threefold: to chair the sittings of the Assembly while ensuring that the Standing Orders are observed and that the rights and privileges of the National Assembly and of its Members are protected; to oversee the services of the Assembly; to represent the Assembly in Québec and abroad, particularly in its relations with other Parliaments.

#### **Vice-presidents**

There are three vice-presidents, the first two of which are elected among the Members of the parliamentary group forming the Government and the third, among the Members of the parliamentary group forming the Official Opposition. They assist the President in his duties and enjoy the same prerogatives and the same authority as the latter when they replace him in his parliamentary duties.

#### **Leader**

A Member who is responsible for the parliamentary activity of his party

#### **House leader**

A Member who is responsible for establishing the parliamentary strategies of his group.

#### **Deputy House leader**

A Member who assists and replaces the House Leader in his duties.

#### **Whip**

A Member who is responsible for discipline within his group and who coordinates the activities of the Members in the Assembly, in committees, and within delegations.

#### **Deputy Whip**

A Member who assists and replaces the Whip in his duties.

### **Definitions**

#### **● Parliamentary group forming the Government**

The group of Members whose party won the majority of seats in a general election. Their leader becomes the Premier, and he chooses, generally among the Members of this group, those who shall become Ministers.

#### **○ Parliamentary group forming the Official Opposition**

The group of Members whose party won the second largest number of seats in a general election. The leader of this parliamentary group becomes the Leader of the Official Opposition.

#### **○ Independent Member**

A Member of Parliament who is not a member of a recognized political party under the Standing Orders of the National Assembly or who, during a term of office, leaves a group without joining another. An independent Member may join a parliamentary group at any time during a legislature.

# The National Assembly and PARLIAMENTARY WORK



During their term of office, the Members are called upon to discuss a multitude of issues concerning the public affairs of Québec. Whether it be to express an opinion, an intention or to pass a bill, several methods are at their disposal in order to examine a question concerning a given societal issue and to fully take part in the parliamentary proceedings. The debates at the National Assembly and in the committees proceed according to a set of rules based on the British parliamentary system guaranteeing freedom of speech to Members and their legal authority over the business of the State.

## SCHEDULE OF SITTINGS

The Standing Orders of the National Assembly establish a work calendar that is divided into two periods: from the second Tuesday in March until 23 June at the latest, and from the third Tuesday in October until 21 December at the latest. The Standing Orders also provide for «intensive» periods of work, beginning on 25 May and on 25 November, during which the Members also sit on Friday and the sitting hours are extended..

The standing committee sittings may take place all year long. However, none of these sittings may be held when the Routine Proceedings are underway in the National Assembly Chamber.

Outside of the periods provided for in the Standing Orders, the Assembly, at the request of the Premier, may hold extraordinary sittings. This request is addressed to the President or, in his absence, to the Secretary General.

### Extraordinary sitting on 15 December 2005

At the request of the Premier, Mr. Jean Charest, the National Assembly was summoned to meet as a matter of urgency in an extraordinary sitting, on 15 December 2005, to proceed with the passage of Bill 142, An Act respecting conditions of employment in the public sector, and of Bill 124, Educational Childcare Act.

### ASSESSMENT OF WORK AT THE ASSEMBLY

## A sitting of the Assembly

A sitting of the Assembly is divided into two distinct periods: the Routine Proceedings and the Orders of the Day.

ROUTINE PROCEEDINGS	ORDERS OF THE DAY
<p>The Routine Proceedings are composed of nine items of business set aside for information given by the Government to the National Assembly. One of the more interesting items is certainly Oral Questions and Answers, which takes place on every sitting day. The order in which the items of business under Routine Proceedings are taken is as follows:</p> <ol style="list-style-type: none"><li>1. Statements by Ministers</li><li>2. Introduction of bills</li><li>3. Tablings</li><li>4. Complaints of Breach of Privilege or Contempt and Personal Explanations</li><li>5. Oral Questions and Answers</li><li>6. Deferred Divisions</li><li>7. Motions Without Notice</li><li>8. Notices of Proceedings in Committees</li><li>9. Information on the Proceedings of the Assembly</li></ol>	<p>The Orders of the Day are devoted mainly to debates on bills at either of the stages of their consideration. It is also at this time that the National Assembly takes into consideration all other substantive motions for debate. The Orders of the Day are composed of five items of business that must be taken according to a predetermined order of priority:</p> <ol style="list-style-type: none"><li>1. Business Having Precedence</li><li>2. Urgent Debates</li><li>3. Debates on Reports from Committees</li><li>4. Other Business Standing on the Order Paper and Notices</li><li>5. Business Standing in the Name of Members in Opposition</li></ol>

### A FEW NUMBERS IN 2005-2006

- Three ministerial statements were made;
- Sixty-three bills were introduced until the prorogation of the first session, on 10 March 2006;
- Nine hundred and ninety-three documents were tabled in the Assembly, including annual reports of ministries and public bodies, committee reports and petitions.



### A few explanations concerning the Routine Proceedings

**Statements by Ministers** - A Minister may make a statement to the Assembly on any subject he deems to be relevant, such as the announcement of a governmental policy or the Government's reaction to a given event.

**Introduction of Bills** - It is during Routine Proceedings that a bill may be introduced. Members do not discuss the content of the bill at this point but simply allow the text thereof to be submitted for consideration during the subsequent stages of the legislative process.

#### TABLING OF A PETITION

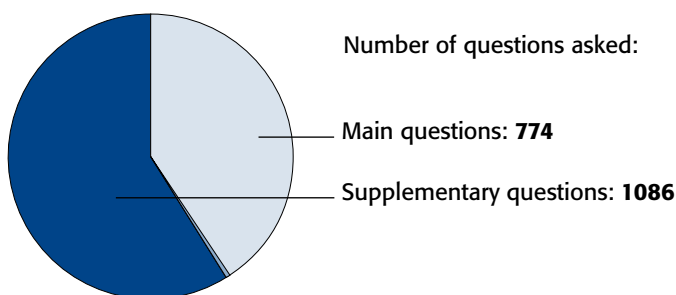
The right of citizens to present a petition to the National Assembly is a fundamental right that is codified in the *Québec Charter of Human Rights and Freedoms*. Therefore, every person or association of persons may address a petition to the Assembly, through a Member chosen by the petitioner, for the redress of a situation deemed unfair.

In order to promote the proper conduct of the parliamentary proceedings, the President gave a directive, during the Routine Proceedings of 23 November 2005, to set at 250 the maximum number of words that the statement of facts may contain. Any petition that fails to comply with this guideline may be ruled out of order and not be granted permission to be tabled in the Assembly.

### Oral Questions and Answers

This item of business is without a doubt the most familiar to citizens. During this 45-minute period, Members may question Ministers on matters of public interest, stemming from current events or urgent matters, within their competence or that of the Government.

57 hours were devoted to Oral Questions and Answers.



### DEBATES UPON ADJOURNMENT

Any Member who is of the opinion that a matter he raised during oral question period has not been sufficiently discussed may request *a debate upon adjournment*. He must give notice to the President of the matter he wishes to discuss no later than thirty minutes after the end of oral question period. In 2005-2006, 43 such debates were held, on Tuesdays and Thursdays each week, at the time appointed for the rising of the Assembly.

Not more than three debates may be held upon adjournment on any sitting day. The Member who raised the matter and the Minister responding thereto may each speak for up to five minutes and the Member may thereafter speak for up to two minutes in reply.

### GLOSSARY

#### Motion

Procedural act by which a Member places some matter before the Assembly for its decision. He may thus ask the Assembly to carry out an action, order that an action be carried out or express an opinion on a given subject.

In 2005-2006, 222 motions without notice were carried, including the following:

- The death of His Holiness Pope John Paul II
- The contribution of Aboriginal peoples to the development of Québec.
- The 65<sup>th</sup> anniversary of women obtaining the right to vote in Québec

### A few explanations concerning the Orders of the Day

With very few exceptions, the motions debated during this period are placed on the *Order Paper and Notices*. Notwithstanding Business Standing in the Name of Members in Opposition, it is generally the Government House Leader who indicates which item of business on the Order Paper will be discussed. However, this prerogative is limited by the order in which the items must be taken.

**Business Having Precedence** - As the name indicates, these items of business have precedence over all other matters, owing to their importance or urgency. The Opening Speech of the Session, delivered by the Premier, ranks first among the items of business having precedence, as well as the speeches by the Leaders of the parliamentary groups or their representatives, within the framework of the ensuing debate thereon. Among other business having precedence, the Budget Speech and want of confidence motions should also be mentioned.

**Urgent debates** - Any Member may request the holding of an urgent debate. The President authorizes the holding of such a debate if he deems that the request concerns a specific and important matter involving the responsibility of the Assembly and which cannot otherwise be discussed.

**Debates on reports from committees** - The reports from committees containing recommendations are placed on the Order Paper immediately after they have been tabled in the Assembly and must be taken into consideration within 15 days following this tabling.

The debates on Business Standing in the Name of Members in Opposition are held every Wednesday morning, excepting during the period of extended hours of meeting or when business having precedence is underway.

*Le Répertoire législatif 2005 de l'Assemblée nationale*, which constitutes a summary of the legislative work carried out in the past year, contains, among other information, a descriptive file for each public statute, a table of the amendments made to the public statutes, the list of public statutes per ministry or sector and an alphabetical index relating to the public statutes.

Each year, the National Assembly publishes an *Annual Statutes Compilation* in French (Les lois du Québec) and in English (Statutes of Québec). In addition to the text of each statute assented to, the compilation also contains the table of modifications made since 1977 to the Revised Statutes of Québec. It is a very useful documentary tool for Members, citizens and lawyers.

---

**Other Business Standing on the Order Paper and Notices** - It is during this period that the Assembly engages in the various stages of the consideration of a bill, more particularly the passage in principle, the clause-by-clause consideration in committee of the whole and the passage of the bill.

Only a Minister may introduce a bill having a financial impact. However, barring this exception, any Member has the right to introduce a bill at the National Assembly, and he may thereupon entrust its drafting to the legal and legislative services of the Assembly.

**During the last year, the Assembly passed 63 bills, more specifically:**

- 45 introduced by Ministers, 65 % of which were adopted unanimously;
- 2 introduced by Members, all of which were adopted unanimously;
- 16 private bills, all of which were adopted unanimously.

**On average, 115 days elapsed between the introduction of these bills and their passage.**

## THE STANDING COMMITTEES

An important part of parliamentary work is not carried out in the Assembly itself, but in the committees, where Members exercise their duties as legislators and controllers of the Government's actions and the public administration. The committees are composed of a dozen Members and are responsible for the examination of any matter within their competence. It is in committee that the population can be heard during public consultations on bills or on important societal issues. It is also in committee that the Members give detailed consideration to bills, closely examine the activities of the ministries and governmental agencies, study the budgetary estimates of the Government and may also choose, on their own initiative, to examine any other matter within their field of jurisdiction.

- Chairman**  
A Member of one of the parliamentary groups, elected by the members of the committee for a two-year term, he organizes and chairs the proceedings of his committee. The chairman of the committee takes part in the debates and has the right to vote.
- Vice-chairman**  
A Member of a parliamentary group other than that of the chairman, elected by the members of the committee for a two-year term, he assists the chairman in his duties and replaces him when necessary.

### Highlights: two travelling parliamentary committees

Two parliamentary committees met outside of the Parliament to hold public hearings within the framework of general consultations.

### General consultation on the religious heritage

Churches and chapels, rectories, convents and monasteries, sanctuaries, Stations of the Cross and calvaries, stained-glass windows, sculptures, paintings, liturgical vestments and objects, archives, organs, cemeteries: all constitute elements of the religious heritage of Québec. In addition to this movable and immovable property are the traditions and knowledge detained, among other persons, by the religious community. The Committee on Culture is concerned with the future of this heritage, whether under the authority of the Catholic Church or of any other religious tradition.

This describes how the Committee views the issue that is at the core of its order of initiative on the religious heritage. Within the framework of the general consultation, the committee held public hearings in the following cities: Montréal, Gatineau, Sherbrooke, Saguenay, Québec, Rimouski and Trois-Rivières.

One hundred and two individuals and organizations were heard during these hearings. Furthermore, the Committee held special consultations to hear some experts in the matter. A total of 118 briefs were submitted, and some sixty opinions were received during the on-line consultation.

### Orders of initiative

On their own initiative, the committee members examine draft regulations and regulations, the orientation, activities and management of public agencies and any other matter of public interest.

## Select Committee on the Election Act

The Select Committee on the Election Act was established by the National Assembly in June 2005 for the purpose of examining various matters relating to the voting procedure, the holding of elections and measures promoting the representation of the regions, women, youth, ethnocultural minorities and Native people. The Select Committee is composed of nine Members and is accompanied throughout its proceedings by a committee of eight citizens. The Select Committee invited the citizens to take part in its proceedings by publishing several notices in the newspapers. Moreover, it distributed in 3,340,000 Québec households an information pamphlet and published an information package, a consultation form and a study questionnaire.

The interest raised by this Select Committee surpassed all expectations, as the following data indicates: 361 briefs submitted during the general consultation, 1747 persons took part in the on-line consultation, 6200 paper copies of the information package were forwarded in French or English to the citizens who so requested it, 366 persons and organizations heard during the public hearings, 22 experts and representatives of the political parties heard during the special consultations.

The public hearings took place between the months of January and March 2006, in 16 cities of Québec. The final report of the Select Committee as well as the report from the members of the citizens' committee were tabled in spring 2006.

## Mandates of the standing committees

The sector-based standing committees may carry out three types of mandates: orders of reference, orders of initiative, and statutory orders. The complete list of mandates carried out by the standing committees in 2005-2006 can be found in appendix.

### 1. Orders of initiative

In the course of 2005-2006, the committee members took the initiative to more closely examine the issues affecting various sectors of activity. The organization of these mandates requires several deliberative meetings during which the members prepare consultation or information papers, hear experts, plan public hearings and draft final reports containing recommendations addressed to the Government.

Other than the religious heritage, the following are the main subjects that were examined by the Members: food safety, the diversity of cultural expressions, the school success of Native people, the protection of investors in Québec, the Bureau d'évaluation médicale, highway safety, the impact of climatic warming in Northern Québec. Standing commit-

tees also took the initiative to examine the orientation, activities and management of the following public agencies: the Société d’habitation du Québec, the Centre de recherche industrielle du Québec, the Conseil supérieur de l’éducation, the Commission d’évaluation de l’enseignement collégial du Québec, La Financière agricole du Québec, Investissement Québec, the Kativik Environmental Quality Commission, the James Bay Environmental Quality Evaluating Committee and Review Committee.

**2. Orders of reference**

**Clause-by-clause consideration of bills**

The standing committees gave consideration to 63 bills of which a complete list can be found in appendix. Included therein are the Government bills, 16 private bills and 11 bills whose consideration had not been completed as at 31 March. It is interesting to note that, regarding the bills as a whole, 3475 sections were examined and 1046 amendments were adopted out of the 1158 amendment proposals made.

**Orders of reference**

At the request of the Assembly, the committees examine bills, the estimates of expenditure, and any other matter that may be referred to them.

## GLOSSARY

### General consultation

A general consultation is open to the population at large. Prior to its holding, a public notice must be published in selected newspapers, in the Québec Official Gazette and on the Internet site of the Assembly inviting any individuals and organizations interested in the matter under consideration to submit a brief to the committee. Public hearings are then held by the committee in order to discuss the submissions received.

### Special consultations

Special consultations are limited to individuals and organizations chosen by the Committee or by the Assembly owing to their knowledge or expertise regarding the matter under consideration.

## General and special consultations

In 2005-2006, no less than 1082 groups and individuals came before the committees to give their opinion on the various matters on which consultations were held and 1298 briefs were submitted to the committees (the annual average is 640 briefs). The committees also received 3000 opinions submitted during five on-line consultations. These consultations enable the parliamentarians to properly assess the issues arising from a matter under consideration.

The following are some of the matters on which public consultations were held: the youth protection bill, the educational childcare bill, the paper entitled «Pharmaceutical Policy», the bill on reserved designations and added-value claims, the bill on access to documents held by public bodies and the protection of personal information, the five-year report on the development of manpower training, the bill on school denomination, the bill on the director of criminal and penal prosecutions, the bill on sustainable development, the policy paper on off-highway vehicles, the draft bill to replace the *Election Act*. Finally, it should be mentioned that the Committee on Social Affairs published a final report containing nine recommendations following the general consultation with reference to the paper entitled «Towards a new social contract for equality between women and men».

## Consideration of the estimates of expenditure 2004-2005

For a three-week period, during the month of May, the committees considered the estimates of expenditure that the Government placed before the Assembly for its authorization, as stipulated in Standing Order 282. Upon the conclusion of their mandate, the committees had devoted slightly over 192 hours to the examination and adoption of the estimates of expenditure granted to the ministries and agencies, totalling over 55 billion dollars.

## 3. Statutory orders and orders in compliance with the Standing Orders

Statutory orders stem from an act or a regulation arising therefrom, or they may originate from a Standing Order of the National Assembly. As an example, the Act respecting educational institutions at the university level enjoins the Committee on Education to hear the head officers of these establishments every three years. To carry out this mandate, the Committee developed an analytical grid comprising 70 indicators and heard the head officers of 19 universities. The final report of the Committee contains 32 recommendations.

## INTERPELLATIONS

Pursuant to the Standing Orders of the National Assembly, every Member sitting in opposition may interpellate a minister on a matter of general interest for which he is officially responsible. The interpellation is held at a meeting of the appropriate standing committee, on Friday morning, from 10.00 o'clock a.m. to 12.00 o'clock noon. One interpellation may be held each week during the periods in which the Assembly ordinarily meets (excepting during intensive session, when none may be held).

The Government's ministers were interpellated in committee on the following matters:

- the dismantling of the educational childcare network;
- kidnappings, forcible confinements and abuses of authority towards Québec's children;
- Québec's family policy;
- the assessment of the election commitments in the health and social services sector;
- the situation of Québec's regions;
- Québec's energy strategy;
- the state of federal-provincial relations;
- sustainable development in Québec;
- the transport policies;
- the health sector promises;
- the Government's budget policies.

### The Committee on Public Administration

This Committee is required to hear public administrators on their management. It carries out this mandate by inviting the deputy ministers and the chief executive officers of public bodies to come before it to answer the questions of parliamentarians on their annual management reports or to discuss the observations contained in the Auditor General's reports. In 2005-2006, the Committee heard a dozen deputy ministers and chief executive officers of public bodies and it analyzed 16 annual management reports during deliberative meetings. Pursuant to the Standing Orders of the National Assembly, the Committee must also examine all financial commitments equal to or exceeding \$25,000 that the Treasury Board, the Executive Council, or any ministry has authorized. In 2005-2006, the Committee examined 19,000 financial commitments.

### Facilitating citizen participation and access to documents

The modernization of proceedings within the standing committees continued in the course of 2005-2006, which contributed to bringing the elected officials and the citizens even closer together and to facilitate the work of parliamentarians. For instance, the committees held five on-line consultations during which over 3000 opinions were submitted.

They also held a dozen videoconferences and webcast all of their proceedings, including those of the travelling committees. These initiatives complement the existing methods, which include fast access on the Internet site to the transcript of all debates and the existence of a Web page for each of the committees, where all information relating to the proceedings is available.

In order to further facilitate standing committee work, the Greffier (Clerk) project was developed and will be operational in the near future. This will enable Members to have access, from their portable computer, to all pertinent information: texts of bills and amendments, documents tabled, votes and proceedings, consultation and background papers, briefs and reports.

# The National Assembly and THE CITIZENS

## **Bringing the citizens and their elected representatives closer together**

During recent decades, the National Assembly has equipped itself with a vast array of communications methods and tools for the purpose of bringing the citizens and their elected representatives closer together. It is, incidentally, one of the most pioneering parliamentary assemblies in the world in this regard.

## **THE EDUCATIONAL ACTIVITIES**

To stimulate the interest of people of all ages in the exercise of democracy and to provide the tools that will contribute to making them active and well-informed citizens, the National Assembly has developed various activities and publications to educate on democracy.

### **The President's tour of the schools**

In order to further instruct students on the role of the National Assembly, its history and its achievements, during winter 2006, the President of the National Assembly, Mr. Michel Bissonnet, conducted a tour of 14 high schools, during which he met with over 5000 students and teachers from six regions of Québec, namely the Côte-Nord, Charlevoix, Capitale-nationale, Montérégie, Nord-du-Québec and Saguenay—Lac-Saint-Jean regions. This tour, whose theme was The Challenge of Democracy, falls within the framework of the educational activities of the Assembly. Its aim is to heighten the awareness of young people on the importance of taking part in the democratic process and to present the Assembly as the forum for debates and discussions on the issues affecting their daily lives.

### **The tournament and the parliamentary simulations**

The parliamentary simulations allow the participants to understand the operation of the Assembly. Thanks to this role playing, they draft and discuss bills while learning the art of compromise, consensus and the respect of others.

#### Jean-Charles-Bonenfant Foundation

Since its creation on 21 June 1978, the mission of this Foundation has been to improve, among the general public and young people in particular, the knowledge of our political and parliamentary institutions through both parliamentary simulations and internships.

It has contributed over one million dollars in scholarships for the realization of parliamentary internships in addition to promoting the apprenticeship of our political and parliamentary institutions by young Québec university students. Close to one hundred young people have benefited from these internships and have been able to profit from the experience in their career development aspirations.

#### PARLIAMENTS IN HIGH SCHOOLS

On 24 November 2005, Mr. Michel Bissonnet and Mrs. Diane Leblanc, respectively President and Vice-President of the National Assembly, launched an ambitious project on democracy education: Parliaments in high schools.

The Jean-Charles-Bonenfant Foundation want to promote the establishment in high schools of actual parliaments that will have as a reference the Standing Orders of the Québec National Assembly. These parliaments, based on the student councils defined in the Education Act and which already exist in high schools, will include a premier, ministers, members and a president, all elected.

There are currently four Québec high schools experimenting the project. The objective is to establish this project in 250 high schools within the next 5 years.

### Parliamentary internships, a unique experience

Each year, for a 10-month period, the Foundation interns enjoy a hands-on experience of the numerous aspects of Québec parliamentary life. They become more familiar with the operation of the National Assembly and of the institutions that are accountable thereto, namely the Auditor General, the Public Protector, the Chief Electoral Officer and the Lobbyists Commissioner.

Subsequently, each one is paired with a Member of the Government and then with a Member sitting in opposition. The interns also take part in a mission abroad and are required to draft a dissertation.

The scholarship interns of the Jean-Charles-Bonenfant Foundation tabled their dissertations in the presence of the Vice-President of the National Assembly, Mrs. Diane Leblanc, on 29 June 2005. This ceremony marked the end of an internship that began in September 2004.

The dissertations submitted by the five scholarship holders concerned the following subjects:

- *Conflits et convergences : la culture politique des élites francophone et anglophone du Québec au début du 19<sup>e</sup> siècle* (Jean-Francis Clermont-Legros)
- *L'efficacité des missions parlementaires* (Pierre-David Jean)

### Members of the public administration learn the rudiments of parliamentary procedure

In spring 2005, a course on parliamentary procedure was developed to meet the needs of the Justice Ministry lawyers. Two courses were offered, the first in Québec City, in May 2005, and the second in Montréal, in October 2005. Over 100 lawyers took part in these two three-hour sittings.

Furthermore, in winter 2006, a course was also prepared for the personnel of the Chief Electoral Officer, the Lobbyists Commissioner, the Commission d'accès à l'information, the Public Protector and the Auditor General.

### **PARTNERSHIP AGREEMENT BETWEEN THE ASSEMBLY AND LAVAL UNIVERSITY**

In June 2005, the National Assembly of Québec and Laval University signed an agreement, for an initial duration of three years, which includes, among others provisions, the creation, by Laval University, of courses on law, parliamentary procedure and institutions, as well as the participation of professors in studies related to the fields of interest of the Assembly.

The partnership also enables the participation of the National Assembly in research work carried out by professors or students undertaking graduate studies on the parliamentary institution. This agreement also enables the National Assembly personnel to welcome Laval University students for internships and provide support thereto.

### **AN ASSEMBLY THAT IS OPEN TO THE CITIZENS**

In the company of guides, the citizens are invited to visit the Parliament Building, which was designed by architect Eugène-Étienne Taché and whose construction spanned from 1877 to 1886. This building is part of a group that has been designated a national historic site. During the tour, guides explain the history and operation of the National Assembly of Québec. At the same time, visitors have the opportunity to discover and admire the special architectural features of the building and the richness of the art displayed therein. Tours are given in French and English and, upon reservation, in Spanish, Italian and Québec sign language.

On 5 April 2005, some one hundred people took part in the third edition of the *Journée du livre politique au Québec* at the Library of the National Assembly. The launching of the essay entitled «Nous, peuple du Québec - Un projet de Constitution du Québec» by the Member for Mercier, Mr. Daniel Turp, and of the *Répertoire des fonds d'archives de parlementaires québécois* of the Assembly Library, as well as round table discussions hosted by journalist Françoise Guénette were on the Day's agenda.

#### LA GRANDE COLLECTE DE LIVRES (BOOK-RAISING EVENT)

The President of the National Assembly of Québec, Mr. Michel Bissonnet, and the Chief Executive Officer of the Fondation des parlementaires québécois Cultures à partager, Mrs. Jeanne L. Blackburn, took part in the launching of a vast book-raising event among high school students, on 26 April 2005.

This book raising was one of the activities falling within the framework of the *Montréal, World Book Capital City 2005-2006* event.

From 1 May to 15 June, students from high schools throughout Québec were invited to actively take part in this book raising by giving a book, in which they placed a bookmark with their comments, and by donating one dollar to cover the book's shipping costs. The Members of the National Assembly were, for their part, responsible for collecting books in their respective ridings. The books gathered were sent to local community organizations and to developing countries.

The objective was to collect 1000 books in each of the high schools and to send at least 100,000 books to developing countries who are partners of the Fondation. On 15 September 2005, the President of the National Assembly, Mr. Michel Bissonnet, announced that this objective had been exceeded, as over 107,000 books were gathered during the book-raising event.

#### UNVEILING OF A BUST AND THE CHAUVEAU EXHIBITION

The President of the National Assembly, Mr. Michel Bissonnet, unveiled on 2 November, at the Assembly Library, a bust of Pierre-Joseph-Olivier Chauveau (1820-1890), first holder of the office of Premier of Québec.

This bust was created by artists Suzanne Gravel and Yvon Milliard.

Mr. Charles Robert, a descendent of Chauveau, Principal Procedural Clerk at the Senate of Canada, attended this unveiling ceremony, in addition to the Premier of Québec, Mr. Jean Charest, the Leader of the Official Opposition, Mrs. Louise Harel, and the Leader of the Action démocratique du Québec, Mr. Mario Dumont.

An intellectual figure who marked the 19<sup>th</sup> century, Pierre-Joseph-Olivier Chauveau was a Member, then a Minister and finally Premier of Québec, from 1867 to 1873. A native of Charlesbourg, he transformed his passion of books and education into the driving force behind his political and social commitment.

On 2 November, the Library also launched the exhibition entitled «*Entre savoir et pouvoir: la collection de Pierre-Joseph-Olivier Chauveau*», displaying some of the outstanding items of the Chauveau Collection, which is classified as historical property and conserved by the Library, as well as objects having belonged to this politician.

#### Exhibition on political caricature

Over 2000 persons visited the exhibition devoted to political caricature, from 14 June to 28 August 2005. Current and former parliamentarians had been invited to select their favourite caricatures. This exhibition brought together 80 drawings by editorial cartoonists hailing from various regions of Québec. Both *tormentors* and *victims* socialized at the opening of the exhibition in the presence of the President of the National Assembly, Mr. Michel Bissonnet, the Vice-President of the National Assembly and steering committee chairman of Political Book Day, Mrs. Diane Leblanc, and several parliamentarians and cartoonists.

#### 65<sup>TH</sup> ANNIVERSARY OF THE RECOGNITION OF WOMEN'S RIGHT TO VOTE

On Tuesday, 19 April 2005, a commemorative ceremony was held in the Legislative Council Chamber at the Parliament Building on the occasion of the 65<sup>th</sup> anniversary of the recognition of women's eligibility and right to vote. The President of the National Assembly, Mr. Michel Bissonnet, awarded the Medal of the National Assembly to Mrs. Madeleine Parent, representative of the women committed to fighting for women's right to vote.

### COMMUNITY FEAST

It was a day of celebration at the National Assembly on Sunday, 26 June 2005. Numerous citizens took part in the festivities surrounding the 10<sup>th</sup> anniversary of the Commission de la capitale nationale du Québec (national capital commission). Brunches, a tour of the Parliament Building and its gardens, a performance by the musical group Mauvais Sort and activities for children awaited visitors.

On this occasion, the President of the National Assembly, Mr. Michel Bissonnet, and the Chairman of the Commission de la capitale nationale, Mr. Pierre Boulanger, officially launched the Place de l'Assemblée-Nationale and the Promenade Eugène-Étienne-Taché.

## COMMUNICATIONS

### The publication *Memories of Bronze*

To complement their tour of the National Assembly, visitors may now obtain the information folder *Memories of Bronze*. This publication enables them to learn more about the architecture, ornamentation, statues and the history of the Parliament Building. This information and reference tool mainly presents each of the statues along with a brief description thereof. This free publication, published in both French and English, is available at the Communications Directorate and at the visitor services desks.

### Internet site

In 2005-2006, the Assembly continued to develop the content of its Internet site. The capacity to simultaneously broadcast live audio and video debates passed from two to four events. Furthermore, citizens were given the opportunity to submit their opinion on five subjects being examined in parliamentary committee via on-line consultations. It should be noted that new historical information is also now available, particularly with the addition of the reconstructed debates of the Second Session of the Eighteenth Legislature (from 10 January 1933 to 13 April 1933).

Moreover, a redevelopment of the Internet site was undertaken for the purpose of further meeting the needs of the various clienteles (citizens, parliamentarians, young people, specialists, etc.). This large-scale project, which shall span three years, requires a complete review of the contents that are broadcast and the creation of new on-line services. The main objectives of the redevelopment project are:

- to bring the citizens closer to the Parliament and its Members by fostering increased participation in the proceedings of the Assembly using the new information technologies;
- to present information in an engaging manner by placing emphasis on the Members and the parliamentary proceedings;

- to broadcast information in a personalized fashion according to the needs of each clientele;
- to increase the interest of young people in the activities of the Assembly.

### The National Assembly Channel

The television channel of the National Assembly is a unique tool that allows Québec's population to learn more about the machinery of our parliamentary democracy. Since its creation in 1978, the Channel has not ceased to modernize itself.

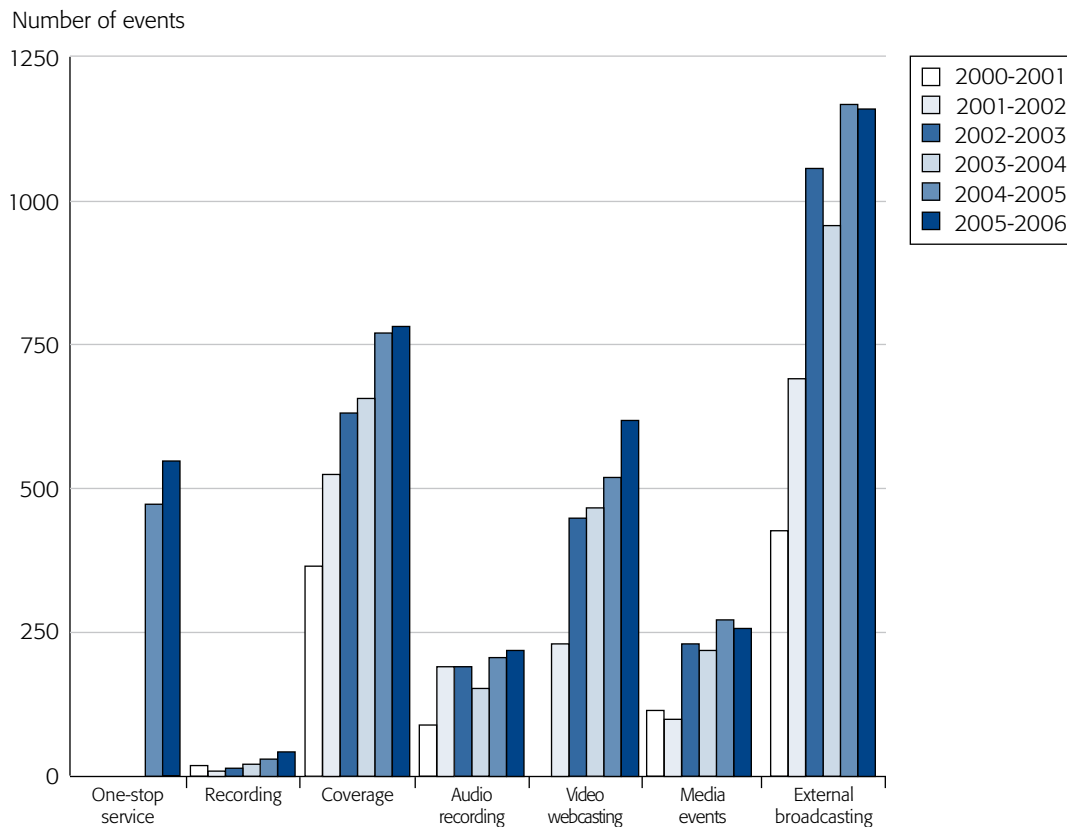

**VIDEOCONFERENCING**

As regards multimedia and videoconferencing, the Assembly provides the Members and its administration with two pieces of videoconferencing equipment. The first is permanently installed in Louis-Joseph-Papineau Room, while the second is mobile and may be used in different rooms.

In the course of the past year, a total of nine videoconferences were organized, seven of which were held during televised parliamentary committees to hear persons residing in various cities of Québec, Canadian provinces and foreign countries such as the United States and Sweden.



# The National Assembly and PARLIAMENTARY DIPLOMACY



## THE OBJECTIVES OF THE INTERPARLIAMENTARY AND INTERNATIONAL RELATIONS OF THE NATIONAL ASSEMBLY

Four major objectives govern the international relations of the National Assembly of Québec:

1. Maintain and reinforce the effectiveness of the parliamentary institution and elected officials in their duties;
2. Actively participate in building a global community founded on democracy, peace, justice, and prosperity;
3. Improve the position of the National Assembly on the international scene and thus contribute to broadening the outreach of Québec society;
4. Enhance the institutional reputation of the National Assembly within interparliamentary networks.

## GLOSSARY

### APF

Assemblée parlementaire de la Francophonie (Parliamentary Assembly of the Francophonie): founded in 1967, composed of 72 Parliaments of unitary, federal and federated States from 54 countries. (National Assembly: full member since 1974)

### CPA

Commonwealth Parliamentary Association: founded in 1911, composed of 171 Parliaments of unitary, federal and federated States from 54 countries. (National Assembly: full member since 1933)

### PCOA

Parliamentary Confederation of the Americas: composed of 35 countries and 300 assemblies, created in 1997 on the initiative of the National Assembly of Québec, composed of the parliamentary assemblies of the unitary, federal and federated States, the regional Parliaments and the interparliamentary organizations of the Americas.

The National Assembly plays an active role in international parliamentary networks. They provide opportunities to exchange information, expertise, experiences and ideas. These relations that a Parliament maintains with one or several others are called interparliamentary relations. Parliamentary diplomacy is exercised within various international organizations as well as with members of the diplomatic and consular corps. Hence, for over half a century, the National Assembly has developed an important network of relations which fall into the following three broad categories:

- multilateral relations (relations between the Assembly and organizations bringing together several Parliaments);
- bilateral relations (relations between the Assembly and one other Parliament);
- interparliamentary cooperation (support to the reinforcement of parliamentary institutions in countries that are developing and that are consolidating democracy).

In our democratic systems, which are based on the separation of powers, Parliaments conduct their international relations independently and in respect of political pluralism. The President of the National Assembly has the responsibility of representing the institution during international activities, whose non-partisan nature is ensured by delegations composed of Members from the various political groups represented at the Assembly.

## MULTILATERAL RELATIONS

### The Parliamentary Francophonie

In April 2005, the National Assembly welcomed to Québec City some forty parliamentarians from the Committee on Education, Communications and Cultural Affairs of the Parliamentary Assembly of the Francophonie (APF). At the conclusion of this meeting, the parliamentarians issued a Declaration supporting the Preliminary Draft Convention on the Protection and Promotion of the Diversity of Cultural Expressions prepared by UNESCO and requesting that the APF be invited to the 33<sup>rd</sup> session of the General Conference of UNESCO. A Québec Member represented the APF at this meeting of the General Conference, held in Paris in October 2005. The members of the General Conference thereupon adopted the Preliminary Draft Convention proposed by the Director-General of UNESCO.

Moreover, a National Assembly delegation took part in the 31<sup>st</sup> session of the APF that was held in Brussels (French-speaking Community of Belgium) from 6 to 9 July 2005. During this session, the President of the National Assembly and Vice-Chairman of the APF, Mr. Michel Bissonnet, participated in the general opening debate of the session on the theme «The contribution of the Francophonie to cultural diversity in

the globalization movement». Also, two young Quebecers attended the third session of the Francophone Youth Parliament (PFJ).

Furthermore, the Québec National Assembly initiated the passage by the APF of resolutions concerning more specifically the decadal strategic framework of the Francophonie, the adoption of a Convention on the Protection and Promotion of the Diversity of Cultural Expressions by UNESCO, and the APF's commitment with regard to the international trade negotiations conducted under the auspices of the World Trade Organization (WTO). For the first time, the APF adopted in plenary assembly a Declaration by the Network of Women Parliamentarians regarding the Convention on the Elimination of All Forms of Discrimination Against Women (CEDAW), a theme which the Québec Section has the responsibility to report on.

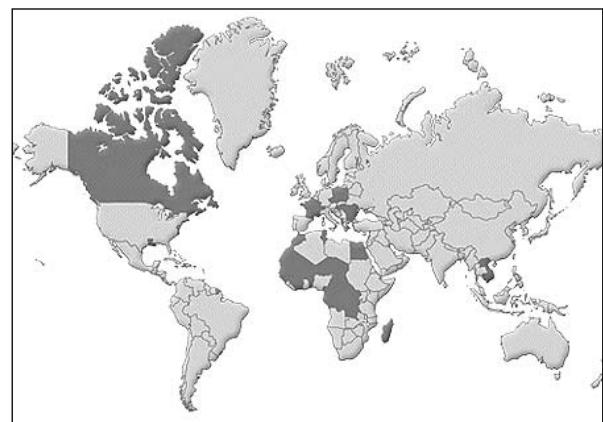
Two seminars were organized during the year in furtherance of the objective of the United Nations respecting the elimination of all forms of discrimination against women, which were attended by the woman Member of the Québec National Assembly responsible for this issue. The first seminar, which brought together women parliamentarians of the Indian Ocean, was held in Madagascar in April 2005, and the second was held in Libreville, Gabon, in December 2005.

In view of the 11<sup>th</sup> Summit of the Francophonie, that will be held in Bucharest (Romania) in September 2006, the APF entrusted the Committee on Education, Communications and Cultural Affairs with the drafting of the opinion of Francophone parliamentarians on the theme «The Francophonie in the direction of an information and knowledge-based society through universal education». Moreover, the Political Committee prepared the second part of its opinion on the implementation of the Francophonie's strategic framework. Two Members of the Québec Section are responsible for drafting these strategic papers that will be presented to the heads of State and Government of the Francophonie at the Bucharest Summit.

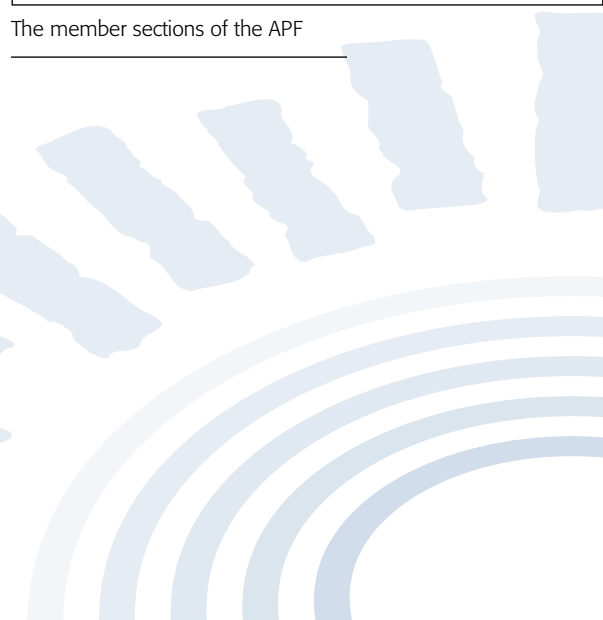
### The Commonwealth Parliamentary Association (CPA)

During 2005-2006, on the occasion of the 48<sup>th</sup> Canadian Regional Conference, held in St. John's, Newfoundland and Labrador, the National Assembly took part in the creation of a Canadian Section of the Network of Women Parliamentarians of the CPA. A Québec woman Member represents the National Assembly on the Network's steering committee.

Furthermore, the National Assembly welcomed the Presiding Officer of the Scottish Parliament, the Right Honourable George Reid, and a delegation of Scottish parliamentarians. This activity falls within the framework of the annual visits of Scottish parliamentarians to North America marking Tartan Day. On this occasion, the parliamentarians exchanged views on issues such as productive immigration strategies and juvenile crime.

An election observation mission led by a Member of the National Assembly was carried out in Bolivia during the general election held on 18 December. This mission was composed of three parliamentarians originating from Québec, Mexico and Brazil.

### The Parliamentary Confederation of the Americas (PCOA)

In December 2005, the National Assembly took part in the PCOA's first election observation mission since the adoption, in May 2005, of the Regulation on election observation missions of the PCOA, a mission whose objectives were to assess election arrangements and to observe how the elections are conducted on polling day in Bolivia.

Generally satisfied with the conduct of the elections, the PCOA parliamentarians noted that, by and large, the electoral procedure had been observed and that the polling had been properly carried out. They were most impressed with the decency and seriousness demonstrated by the Bolivians during this election.

Moreover, from 7 to 11 May 2005, a National Assembly delegation took part in the 6<sup>th</sup> General Assembly of the PCOA which was held in Foz do Iguaçu, Brazil. The parliamentarians of the Americas thus came together primarily to discuss the theme «Migrations, integration and trade agreements». In plenary session, the delegates agreed to the National Assembly's proposal to host the General Assembly of the PCOA in 2008, as part of the celebrations focussing on the 400<sup>th</sup> anniversary of Québec City. The Québec Secretariat of the PCOA, whose headquarters are at the National Assembly, was also given the responsibility of the Committee on Democracy and Peace, chaired by a Québec Member.

Québec parliamentarians attended the 5<sup>th</sup> Annual Meeting of the Network of Women Parliamentarians of the Americas on 7 May 2005, which was held in parallel with the 6<sup>th</sup> General Assembly of the PCOA, on the theme «The impact of migrations in the context of hemispheric integration». A Québec woman Member presented the documentary bank developed by the Secretariat of the Network on the annual theme, as well as a follow-up report on «The impact of the Free Trade Area of the Americas (FTAA) on Women». The Network Secretariat, whose offices are at the National Assembly, contributed to organizing this meeting. The National Assembly kept its seat on the Network's executive committee.

### The United States (ERC, CSG and NCSL)

As an international associated member of the Council of State Governments (CSG) and of its Eastern chapter, the Eastern Regional Conference (ERC), the National Assembly holds responsible positions on the executive committees of both of these associations, as well as the vice-chairmanship of the Committee on Canada–United-States Relations and of the Committee on Energy and the Environment at the ERC. In January 2006, the First Vice-President of the National Assembly, Mr. William Cusano, was named Vice-Chairman of the ERC.

It is the first time that a Member outside of the United States holds this prestigious office, Québec being the only international associated member of this organization. The chairmanship will thus be given to Québec in 2007.

Furthermore, the National Assembly sponsored two resolutions concerning the Western Hemisphere Travel Initiative (WHTI). The First Vice-President of the National Assembly took part in the ERC's extraordinary mission at the United States Congress for the purpose of informing American parliamentarians on the concerns of the ERC regarding the implementation, in 2008, of an American measure that would oblige Canadian and American travellers to present their passport at the land and marine border crossings with the United States.

The National Assembly is also an international associated member of the National Conference of State Legislatures (NCSL). The organization's General Assembly, which met in Seattle in July 2005, adopted an amendment allowing the National Assembly of Québec to sit on the Executive Committee of the NCSL, representing the legislative assemblies associated to the NCSL as international members.

## **BILATERAL RELATIONS**

### **France-Québec Interparliamentary Cooperation**

The 26<sup>th</sup> France-Québec Interparliamentary Committee was held in Paris, from 11 to 17 September 2005. Its discussions focussed on the place of youth and women in politics as well as on public-private partnerships. It had been preceded by an official visit of the President of the Québec National Assembly, on 12 and 13 September, with his French National Assembly counterpart, Mr. Jean-Louis Debré.

Furthermore, a delegation of the Committee on Family and Children's Rights from the French National Assembly visited Québec City to exchange views with their Québec counterparts regarding legislations that recognize same-sex marriages.

Moreover, from 27 June to 2 July 2005, the President of the National Assembly headed a delegation of parliamentarians on a mission to the French Senate. Two themes were more specifically discussed during the working meetings, namely France's role and position within the European Union and the impact of security measures put into place in France since the terrorist attacks of 11 September 2001 and 11 March 2004. The President of the Québec National Assembly, Mr. Michel Bissonnet, also received an invitation from the President of the French Senate, Senator Christian Poncelet, on the occasion.

Finally, a delegation of the Law Committee of the French Senate was welcomed at the National Assembly in September 2005 by Québec Members, with whom they discussed the modernization of the public service.

### **Cooperation with the Parliament of Catalonia**

A National Assembly delegation was welcomed in Barcelona by the Parliament of Catalonia, from 10 to 15 July 2005, during the 1<sup>st</sup> Québec-Catalonia Interparliamentary Committee. The exchanges focussed on water management, the Québec National Assembly parliamentary reform and the reform of Catalonia's status, defining its relations with Spain.

### **Relations with other States and European institutions**

From 1 to 5 May 2005, the National Assembly hosted the 2<sup>nd</sup> meeting of the Québec-Bavaria Joint Parliamentary Committee. The Bavarian and Québec parliamentarians discussed parliamentary work, federalism as well as regional development.

Also, a delegation of the Bavarian Committee on the Environment and Consumer Protection visited Québec City on 4 and 5 October to learn more about Québec's alternative and renewable energy sources. Moreover, two major European committees came to Québec, in December, to meet the parliamentarians of the National Assembly, outside of their attending the World Conference on Climate Change.

The Committee on the Environment, Agriculture, and Local and Regional Affairs of the Parliamentary Assembly of the Council of Europe visited the National Assembly, on 7 December 2005, to discuss sustainable development, renewable energy sources and climate change.

Members of the European Parliament Committee on the Environment, Public Health, and Food Safety met with Members of the National Assembly on 9 December to exchange views on these same issues.

### **New Brunswick-Québec Parliamentary Association**

The objective of the New Brunswick-Québec Parliamentary Association is to foster interparliamentary dialogue between the two institutions. It thus constitutes a forum for the holding of regular meetings to encourage discussions on various issues, including the economy and trade, workforce mobility, transportation, border issues, health, the environment, education, culture and tourism.

The second session of the Association was held in Fredericton in September 2005. The parliamentarians discussed current political and parliamentary events. They also exchanged information and expertise on parliamentary reform as well as on forestry management.

## **INTERPARLIAMENTARY COOPERATION**

For several years now, the National Assembly has played an active role in reinforcing parliamentary democracy, by providing to the parliamentary institutions of States that are developing and consolidating democracy the technical support needed to develop parliamentary and administrative operations.

Within this framework, a discussion seminar for parliamentarians conducted by two Québec Members took place at the National Assembly of Niger, in Niamey, from 11 to 13 October 2005. This mission enabled Members on both sides to improve their practice of parliamentarism by sharing their experiences as elected officials, legislators and controllers of the governmental activity. Moreover, a technical seminar for plenary assembly and parliamentary committee staff was held at the Benin National Assembly, from 27 to 29 September 2005.

The Assembly also welcomed to Québec City several delegations from partner assemblies. Thus, from 13 to 15 June 2005, Senators and Members of the Cambodian Parliament came to examine the general operations of our Assembly and of its Library. Also, from 5 to 9 December 2005, a delegation of five Members from the National Assembly of Burkina Faso carried out a study tour on the operation of Québec's parliamentary system as regards budgetary control issues.

The Assembly also hosted two multilateral technical seminars developed in close collaboration with the APF's Noria Programme: on parliamentary libraries from 30 January to 3 February 2006; with several directors of legislative services from 20 to 24 February 2006. Technical collaborations were also carried out with the United Nations Development Programme (UNDP) at the Chamber of Representatives of the Kingdom of Morocco and in Algeria with regard to communications (September 2005) and the virtual library (December 2005).

# The National Assembly and THE HERITAGE

*A Policy on accessibility and availability of archives was implemented in September 2005. The main objectives of this policy are to publicize the existence and nature of the institutional and private archives of the National Assembly and to facilitate their access by users with proper consultation conditions, while ensuring that the use, reproduction and publication of these archives comply with prevailing legislation.*

## THE DOCUMENTARY HERITAGE

**Reconstructing the debates** – A ceremony was held at the Library of the National Assembly on 24 May 2005 to mark the completion of the reconstruction of debates. This project, which is an invaluable heritage source and contains a wealth of information for those interested in the evolution of Québec, will have spanned a period of some 27 years. More than 126 persons contributed thereto. The debates of 71 sessions, beginning with 1893, were reconstituted. This represents 3317 sittings.

### Virtual Library

The Library of the National Assembly continued the content development of the virtual library. Indeed, the press documentation files – over two million pages – the Premiers' speeches, briefs tabled in parliamentary committee, a retrospective of the *Journal des débats* (Hansard) and a few rare and valuable books were digitized to enrich the content of its virtual library. Furthermore, the Library of the National Assembly signed a memorandum of understanding with Les Publications du Québec for the purpose of obtaining all digitized documents published by the ministries and Government agencies of Québec.

### The archives

During 2005-2006, the Library acquired three new private archival fonds, two of which are from parliamentarians. Owing to these additions, the number of private archival fonds conserved at the Library Directorate now totals 24.

## COMPUTERIZED CATALOGUE

The Library's **computerized catalogue**, which may be consulted on the Internet site of the National Assembly, now contains 272,419 entries, including 27,216 electronic documents that are accessible on-line. Through the archival storage of digital texts on its server, the Library continues to develop its virtual library, a concept that encompasses more specifically the electronic resources (locally created or digitalized, or acquired from outside suppliers) as well as services to customers using leading-edge technology in order to more efficiently retrieve, process and disseminate information.

### A FEW NUMBERS...

In 2005-2006, the personnel of the Reference Service answered 12,093 information and search requests. Of this number, 3097 were made by parliamentarians, their staff, the personnel of the National Assembly, or agencies under the authority of the National Assembly.

More than 10,386 persons crossed the threshold of the Library in Pamphile-LeMay Building, including 5074 users and 5312 visitors.

Users took advantage of the Library collections at their disposal by carrying out 51,187 consultations on site, by borrowing 6661 documents or by requesting over 184,901 photocopies from sources available at the Library.

## THE ARCHITECTURAL AND URBAN HERITAGE

### Presenting the architectural heritage

Numerous projects focussing on the restoration and presentation of the architectural heritage were carried out during the past year at the Assembly. Several offices of the Parliament Building had not been touched up in many years. Along the same lines, work was carried out on the main landing and staircase of the Parliament as well as in the contiguous spaces, namely the Presidents' Gallery and both vestibules. This work restored the appropriate lustrous finish to the building's symbolic spaces.



Launching of the book *Le Parlement de Québec* – The President of the National Assembly, Mr. Michel Bissonnet, presided over the launching of the book *Le Parlement de Québec, histoire, anecdotes et légendes*, on 22 November 2005 at the Assembly Library. This work written by Gaston Deschênes, a historian who worked at the National Assembly for 30 years, bears witness to the multiple facets of our institution that is over two centuries old. It is a compilation of partly previously unpublished texts on Members as well as on the history, membership and operation of the National Assembly.

The restoration of the cast-iron crowning that adorns the campanile of the Parliament was undertaken during the past year. This piece of architecture dates back to 1895. In order to carry out the restoration work, the structure was removed and transported to a workshop. The following work was carried out: abrasive cleaning of surfaces, complete dismantling of the piece consisting of approximately 450 parts, the replacement of all of the nuts and bolts as well as the missing or damaged parts and the galvanizing and painting of the components. The structure was then reassembled. It was reinstalled at the top of the campanile in spring 2006.



### **The portrait of Mrs. Louise Harel, first woman President of the National Assembly**

On 10 June 2005, the President of the National Assembly of Québec, Mr. Michel Bissonnet, unveiled a painting of the Leader of the Official Opposition, Mrs. Louise Harel, who was President of the National Assembly from 12 March 2002 to 4 June 2003. The author of the canvas, Mr. Denis Jacques, is mainly known for the quality and resemblance of his portraits. He creates paintings that are characterized by the presence of highly realistic figures, notwithstanding their dwelling in imaginary worlds of dreams and mythology.

The painting was placed on exhibit at the Presidents' Gallery, located near the main entrance hall of the Parliament Building. Displayed there are the portraits of the successive speakers and presidents of the National Assembly since 1867, painted or photographed by artists such as Eugène Hamel, who boasts the largest number of presidents' portraits with eight canvasses, Suzor-Côté, Ozias Leduc and, closer to home, Jean-Paul Lemieux and Francesco Iacurto.



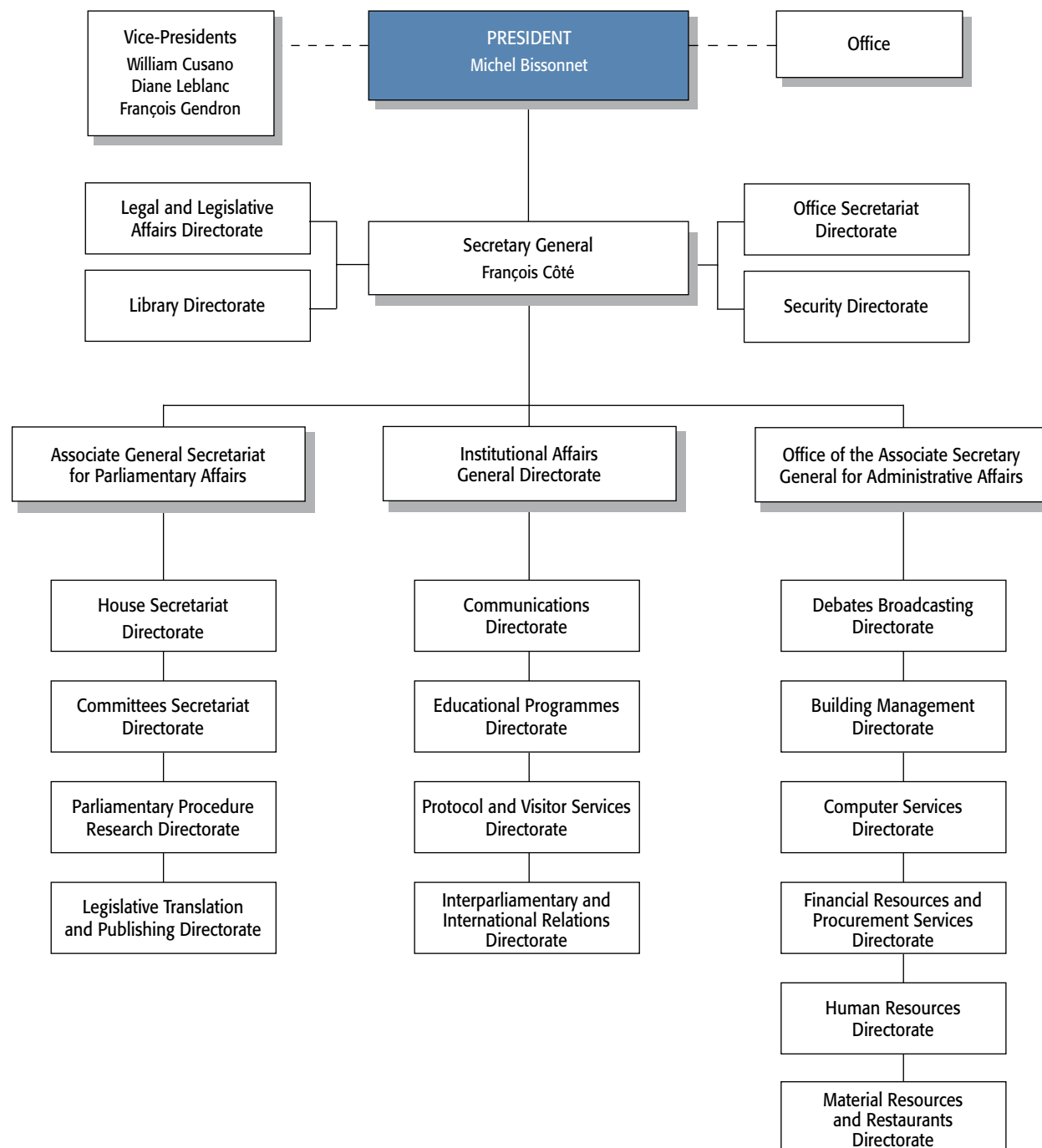
Portrait of Louise Harel,

## THE OFFICE OF THE NATIONAL ASSEMBLY

The management of the National Assembly is carried out within the framework of statutes, regulations and rules that apply thereto. However, in order to preserve the administrative independence of the institution, the Act respecting the National Assembly established the Office of the National Assembly, which is, as it were, its board of directors.

The Office adopts any regulation that it deems necessary for the management of the Assembly. Among its duties, it must approve the budget estimates of the Assembly and regulate in sectors directly involving Members, such as their various allowances and their work conditions.

### Composition of the Office of the Assembly as at 31 March 2006

Other than the President of the Assembly, who is its chairman, the Office of the Assembly is composed of nine Members who are chosen by their peers. The Vice-Presidents of the Assembly may participate in the Office proceedings, but they do not have the right to vote.

THE PERSONNEL

The workforce

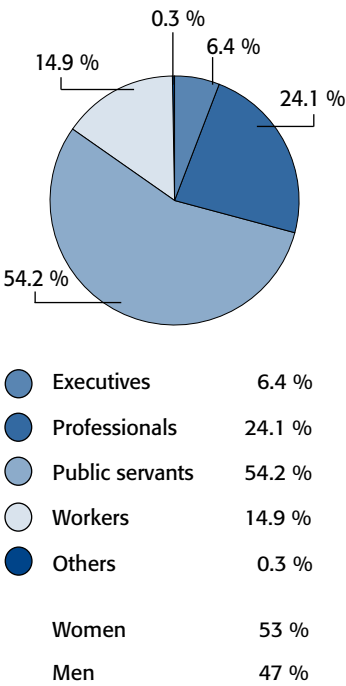
Employee development

To carry out its mission and fulfill its strategic objectives, the Assembly relies on the skills and performance of its personnel. ## A VISIT OF THE DEBATES BROADCASTING SERVICE

On Monday, 3 October 2005, on the day of its 27<sup>th</sup> anniversary, the debates television broadcasting service welcomed close to 250 persons at André-Laurendeau Building for a tour of its new installations. Immediately upon arrival, visitors were invited onto a sound stage, from whence they were literally transported behind the scenes of live television.

## CENTRAIDE CAMPAIGN 2005

The National Assembly raised **\$37,190** during the Centraide Campaign 2005. The campaign conducted at the Assembly focussed on the slogan *C'est si simple de Centraider!* (It is so simple to help one another). The Members and the personnel of the Assembly were urged to help one another on posters displayed throughout the Assembly, on promotional leaflets enclosed with their pay envelope as well as on daily vignettes broadcast on the Intranet Portal. Activities such as the holding of a happy hour to launch the campaign and the traditional desserts auction helped attract people's attention to helping the Centraide cause in addition to collecting **\$4440**.

## ENVIRONMENTAL POLICY

On 12 April 2005, the National Assembly adopted its Environmental Policy. In an effort to further contribute to the conservation of our natural resources, the institution committed itself more determinedly toward recycling, for the purpose of attaining the recycling and upgrading objectives set forth in the Québec Policy on the Management of Residual Material 1998-2008. In order to incite parliamentarians and the political and administrative staff to be environment friendly, in October 2005, the Assembly launched the campaign *Pour l'avenir, je récupère!* (I'm recycling for the future).



## THE ASSEMBLY MODERNIZES ITSELF

### Technological support to the administrative sector

Ever-mindful of improving productivity, optimizing and modernizing the operational methods at the National Assembly, the Computer Directorate put into place various tools to improve, among other objectives, the work of Members in parliamentary committee with the Greffier (Clerk) site. Owing to this system, parliamentarians can connect their laptop computer in the committee rooms and thus have access to a collaborative work space that contains a virtual library of documents comprising reference papers and Internet links.

The new workstations of the personnel of the *Journal des débats* (Hansard) are now configured with Windows XP Pro and have improved system performance and provided more stability. This new equipment has enabled an increase in productivity with regard to the parliamentary proceedings transcribing process.

The office technology resource pool of the National Assembly comprises a total of **1393 microcomputers** and **424 printers** installed on Parliament Hill and in the riding offices.

The President of the National Assembly, Mr. Michel Bissonnet, chaired the Red Cross fund-raising campaign for 2005-2006. The financing activity was a first at the Assembly. This event enabled to collect **\$6196**.

## **THE MANDATES OF THE ADMINISTRATIVE UNITS**

### **The Secretary General**

The Secretary General is the highest-ranking public servant of the Assembly and chief advisor to the President and the deputation in the interpretation of parliamentary procedure. The Secretary General oversees and manages the personnel of the Assembly, sees to the administration of routine business and carries out the other duties that are assigned to him by the Office of the National Assembly, of which he is the secretary.

### **Office Secretariat Directorate**

The Office Secretariat sees to the organization and follow-up of the proceedings of the Office of the National Assembly and informs the Members concerning their working conditions and the services that are available to them.

### **Legal and Legislative Affairs Directorate**

The Legal and Legislative Affairs Directorate advises the Assembly in legal matters and provides all professional services regarding the drafting of private Members' bills and private bills.

### **Library Directorate**

The Library Directorate is responsible for the conservation of parliamentary documents and the management and retrieval of archives. It maintains a collection which corresponds to the needs of current and future users. It carries out studies and conducts research relating to the mandates of parliamentarians and administrative branches, particularly in connection with the business of parliamentary committees.

### **Security Directorate**

The Security Directorate counsels Assembly authorities on security measures and is responsible for the protection of persons and property and for the security of buildings and offices at the Assembly.

### **Associate General Secretariat for Parliamentary Affairs**

The General Directorate of Parliamentary Affairs coordinates, plans, and supervises the activities of the parliamentary affairs directorates and assists the Secretary General in his role of advisor to the Chair of the Assembly.

### **House Secretariat Directorate**

The House Secretariat ensures the preparation, proper conduct and follow-up of the sittings of the Assembly. It assists the Secretary General in the preparation and coordination of the opening and closing of sessions.

#### **Committee Secretariat Directorate**

The Committee Secretariat provides all professional and support services required by parliamentary committees for the organization and conduct of their activities.

#### **Parliamentary Procedure Research Directorate**

The Parliamentary Procedure Research Directorate assists the Secretary General in advising the President, the Assembly and the parliamentary committees on parliamentary procedure matters.

#### **Legislative Translation and Publishing Directorate**

The Legislative Translation and Publishing Directorate is responsible for providing all professional and technical services as regards the translation, revision, editing and printing of legislative texts and for answering the translation needs of other administrative units.

#### **General Directorate of Institutional Affairs**

The General Directorate of Institutional Affairs coordinates, plans and supervises the activities of the institutional affairs directorates and assists the Secretary General in managing the institutional affairs of the Assembly.

#### **Communications Directorate**

The Communications Directorate promotes outreach by informing the public on the role of the Assembly in democracy. It is responsible for the communications of the institution and provides services to the Press Gallery.

#### **Educational Programmes Directorate**

The Educational Programmes Directorate develops, organizes and conducts educational activities for target clienteles and provides professional and technical support during parliamentary simulations.

#### **Protocol and Visitor Services Directorate**

The Protocol and Visitor Services Directorate coordinates protocol activities and ceremonies at the Assembly and is responsible for visitors and information services, as well as for guided tours.

#### **Interparliamentary and International Relations Directorate**

The Interparliamentary and International Relations Directorate advises Assembly authorities on interparliamentary and international relations and coordinates the activities of the Assembly in this area.

#### **Associate General Secretariat for Administrative Affairs**

The Associate General Secretariat for Administrative Affairs plans, directs, coordinates and supervises the activities of the administrative directorates. It also coordinates the deployment of information technologies at the Assembly.



### **Debates Broadcasting and Publishing Directorate**

The Debates Broadcasting and Publishing Directorate is responsible for the broadcasting of parliamentary proceedings, press conferences and certain special events, and for the audio recording of debates for the purpose of transcribing, revising, editing and publishing the Journal des débats (Hansard).

### **Building Management Directorate**

The Building Management Directorate provides all goods and services at the Assembly relating to the management and furnishing of buildings, and telecommunications.

### **Computer Services Directorate**

The Computer Services Directorate is responsible for planning and providing advice and services in the area of office automation and computer systems (software, applications, equipment, training) and manages the computer population and the local and extended networks.

### **Financial Resources and Procurement Services Directorate**

The Financial Resources and Procurement Services Directorate advises and provides services to the administrative units and the Members as regards financial management, budget planning and accounting operations. It also provides procurement services.

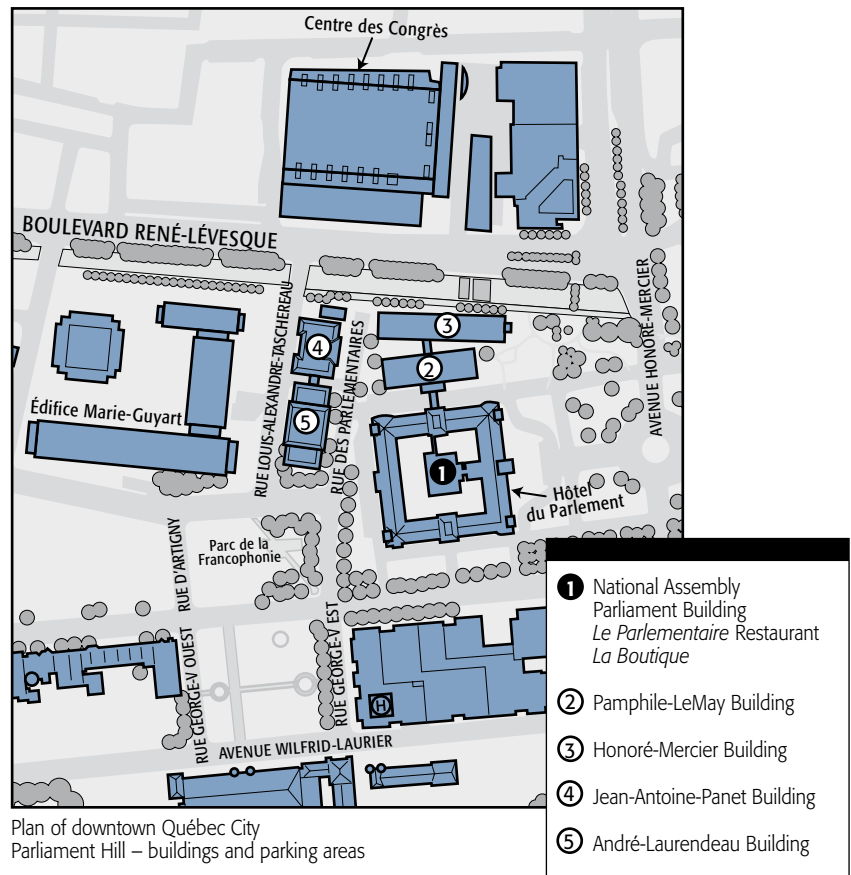
### **Human Resources Directorate**

### **Material Resources and Restaurants Directorate**
